United States Department of Homeland Security (DHS) Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program (FY10 RCPGP) Contract Execution (Council File No. 10-1954)

Dear Honorable Members:

Transmitted, herewith, for City Council consideration is a proposal to negotiate and execute a contract for the City of Los Angeles Housing Department (LAHD) for the Fiscal Year 2010 Regional Catastrophic Preparedness Grant Program (FY10 RCPGP) award from the United States Department of Homeland Security (DHS).

### **RCPGP Background**

On December 6, 2011, the City Council formally accepted the FY10 RCPGP grant for \$3,570,000 (Council File No. 10-1954). As detailed in previous transmittals, the RCPGP is intended to enhance regional catastrophic preparedness and continuity of operations efforts, with the aim of strengthening the nation against risks associated with catastrophic events. The RCPGP centers on the highest risk Urban Areas and surrounding regions, where it will have the most significant effect on our collective security and resilience. Each site participating in the RCPGP works collaboratively to fulfill the program requirements. On February 8, 2013, the California Emergency Management Agency (CalEMA) extended the period of performance from April 30, 2013 to June 30, 2013 (Attachment 1). On April 12, 2013, CalEMA extended the performance period from June 30, 2013 to September 30, 2013 (Attachment 2).

## Los Angeles Housing Department

In a previous Mayor's Report, dated October 3, 2013, authority was requested to amend contractual service agreements for the Regional Disaster Housing Project to a total dollar amount not to exceed \$291,000. This was approved by Council on November 20, 2012. This transmittal serves as clarification that the authority requested was in reference to two Regional Disaster Housing Project contracts. A previously approved contracting authority was to be increased by \$220,000, and a second contract was to be negotiated and executed for an amount up to \$71,000.

This second contract for the Regional Disaster Housing Project meets objectives stated within the FY10 RCPGP grant acceptance transmittal, dated August 4, 2011, to improve LAHD's residential pre- and post-disaster risk assessment tools. The selected contractor, 3Di, Inc., will enhance LAHD's Safety Assessment Module (SAM) and its mobile component, Mobile SAM. This system, which is part of the Regional Disaster Housing Project, allows LAHD personnel in the field to digitally collect residential structure damage assessment data and automatically transmit that information to a central server.

## Recommendations

It is, therefore, requested that the City Council:

- 1. Authorize the Mayor, or his designee, to:
  - a. Negotiate and execute on behalf of the City, a contract with 3Di, Inc. for the Regional Disaster Housing Project for a total dollar amount not to exceed \$71,000, subject to the approval of the City Attorney as to form and legality.
