MOTION

At its meeting of June 5, 2013 (date of letter of determination June 14, 2013) the West Los Angeles Area Planning Commission acted to deny the appeal requesting a variance to permit a height of 50 feet in lieu of the 36 feet height limit for the construction of a single-family dwelling at 360 North Stone Canyon Road in the RE20-1 Zone (Case No: ZA 2012-1395-ZV-ZAA-1A).

The applicant presented substantial evidence to support all of the findings necessary to grant a variance. Action is therefore needed to bring the property into conformity with the neighboring residences and to remedy the hardships caused by the unique circumstances of the property created by the natural down-grade slope.
