

The Los Angeles City Council will conduct a Public Hearing relative to the acquisition by eminent domain of six parcels of real property within and adjacent to the City limits in and adjacent to the northeast area of the San Fernando Valley having APNs 2581-001-042, 2581-001-043, 2581-001-009, 2581-001-010, 2603-002-006, and 2603-002-007, all parcels located in Los Angeles County, to protect the First and Second Los Angeles Aqueducts.

The hearing will be held on September 24, 2013, at 10:00 a.m., or as soon thereafter as the matter can be heard, in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, CA 90012.

Copies of the City Attorney, Los Angeles Department of Water and Power, and City Administrative Officer reports and proposed Condemnation Ordinance (Resolution of Necessity) concerning the proposed action described above may be examined in the Office of the City Clerk, Room 395, City Hall, 200 North Spring Street, Los Angeles, 90012. All persons having any objections to the acquisition by eminent domain of these six parcels of real property within and adjacent to the City limits in and adjacent to the northeast area of the San Fernando Valley having APNs 2581-001-042, 2581-001-043, 2581-001-009, 2581-001-010, 2603-002-006, and 2603-002-007, all located in Los Angeles County, to protect the First and Second Los Angeles Aqueducts may appear before the City Council and show cause why this action should not be taken.
