Dear Ms. King:

The North Hollywood Area Vice Unit is **opposed** to granting the Master Land Use Permit of the current off-sale ABC site located at 10139 ½ West Riverside Drive, Toluca Lake, California, 91602.

The North Hollywood Vice Unit request stipulations and conditions submitted by the applicant to be placed on the location if the Conditional Use Beverage and Conditional Use Permit are granted, along with the following:

- 1. Abide by all applicable laws and manage the property located at 10139 ½ Riverside Drive, Toluca Lake, California 91602, Doing Business As (DBA) Spin the Bottle Wine Studio, LLC.
- 2. That the authorized use shall be conducted at all times with due regard for the character of the surrounding district, and the right is reserved by the Zoning Administrator to impose additional corrective conditions, if, in the Administrator's opinion, such conditions are proven necessary for the protections of persons in the neighborhood or occupants of adjacent property or to revoke or amend this authorization if conditions are not met or operation of the site continues to constitute a nuisance.
- 3. That 8 ounce beer can or bottles shall be sold in six packs only and wine coolers sold in four packs only (or larger quantities), i.e., no single sales are permitted.

4. That wine shall be sold in bottles 750ml or larger in size.

- 5. That "No Loitering" and "Not Public Drinking of Alcoholic Beverages" signs shall be posted at the front, side and rear of the site. These signs shall be in English and Spanish.
- 6. That all graffiti on the site shall be removed or painted over in the same color as the surface to which it is applied within 48 hours of its occurrence.
- 7. That coin operated games, video games, pool tables or similar game activities or equipment are not permitted.
- 8. That the subject facility, including any associated parking shall be maintained in an attractive condition and shall be kept free of trash and debris.
- 9. That all alcohol sales shall be by a clerk 21 years of age or older.
- 10. That an employee of the site will hourly observe the exterior of the site to ensure no loitering occurs. Loiterers will be asked to leave the site.
- 11. That signs shall be posted in Spanish and English that California State Law prohibits the sale of alcoholic beverages to persons who are under 21 years of age.
- 12. That locks be placed on all coolers or areas where alcohol is stored for sale. The locks must be locked during hours in which sales are limited or not allowed.
- 13. That live entertainment is not permitted.
- 14. No alcoholic beverages shall be consumed on any property adjacent to the licensed premises under the control of the licensee.
- 15. That the daily hours of alcohol sales of the subject facility be limited to 6:00 a.m. to 12:00 midnight.
- 16. Any further expansion of the herein authorized conditional use exception involving the establishment or the creation of a new establishment within the applicant's ownership for the selling of alcoholic beverages shall only be permitted after the filing and approval of the proper application for this purpose.
- 17. There shall be no exterior advertising or sign of any kind or type, including advertising directed to the exterior from within, promoting or indicating the availability of alcoholic beverages. Interior displays of alcoholic beverages or signs which are visible to the exterior shall constitute a violation of this condition.
- 18. The establishment fully cooperates with police investigations where the establishment is involved.
