Reason - No nexus between limitation and reported violations. Neighborhood nuisance problems not caused by Appellants, but alcohol & food vendor across the street. Restriction is a taking of vested rights.

The requested hours are currently in force pursuant to prior ZA decisions.

Paragraph 8 - Security Guards

Modified by ZA - two guards Sunday thru Thursday, three Friday and Saturday.

Requested by Appellant - two guards Monday through Sunday.

Reason - In past many years only violence is intoxicated patron who hit security guard escorting patron out. Reason for third guard per LAPD is for guard to stand by bar fixture to prevent entry into back bar area. Solution is to close off access.

Paragraph 17 - Affixing of Tables and Chairs to Floor.

Appellant can affix tables, but unable to affix chairs due to narrow wood leg base which would break on sitting or standing. Presents liability issues to Appellants, and patron injuries; interior guard can prohibit patron dancing.

Appellants' Evidence

- 1. Neighborhood issues caused by taco and beer vendor (Photos & Witnesses).
- 2. Alleged solicitation issues not prosecuted by ABC for lack of evidence (Letter).
- Premises is free of violence. Only violations are dancing and some music noise.
 Real noise comes from Zumba business and Broadway high crime area.
