An ordinance amending Subdivision 1 and adding Subdivision 3 to Subsection (e) of Section 62.109 of the Los Angeles Municipal Code to waive Class "A" permit fees for a property owner repairing sidewalks adjoining his or her property.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Subdivision 1 of Subsection (e) of Section 62.109 of the Los Angeles Municipal Code is amended to read as follows:

- 1. Except for applications subject to the provisions of Subdivisions 2 or 3 of this Subsection, the provisions of this Section apply to all Class "A" permit applications, including, but not limited to, applications to engage in permitted work within a public easement.
- Sec. 2. A new Subdivision 3 is added to Subsection (e) of Section 62.109 of the Los Angeles Municipal Code to read as follows:
 - 3. The provisions of this Section shall not apply to an application by a property owner for issuance of a Class "A" permit to repair or reconstruct existing sidewalk adjoining the property owner's property.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
