## Sandra Figueroa-Villa Biography

Sandra Figueroa-Villa was born and raised in South Los Angeles. She began her community activism in social justice issues at Huntington Park High School and graduated from Roosevelt High School in Boyle Heights. She continued her activism as a student at California State University at Los Angeles.

Ms. Figueroa-Villa has over 40 years' experience working in the non-profit sector. In 1980, she was appointed as the Executive Director of El Centro del Pueblo, which provides services to improve the quality of life for children, youth and families in Los Angeles. Through her leadership and perseverance, she took an organization with a \$25,000 deficit and just two part-time staff and turned it into a nationally recognized social services provider with 80 full-time employees and a \$7 million-dollar annual budget.

In 2005, the agency was debt free, allowing the purchase of an 8,000-sq. ft. facility, which houses the Echo Park Family Source Center. She just completed renovating another 10,000-sq. ft. building to house the agency's clinical programs and leases storefront space to private business. Income generated rolls back into service programs.

Ms. Figueroa-Villa was appointed by Mayor Eric Garcetti to the Los Angeles Board of Police Commissioners in August of 2013. As a Police Commissioner, she serves on several subcommittees, including the Homelessness and the Use of Force Subcommittees. In 2016, she was instrumental in leading the Police Commission's efforts to adopt a policy guiding police officer interactions with people experiencing homelessness, making the LAPD one of only a handful of law enforcement agencies across the nation to have such a policy. In 2017, she helped draft the LAPD's new use of force policy emphasizing de-escalating situations before resorting to the use of deadly force. Both policies further the LAPD's nationally recognized leadership in implementing 21st century policing principles and practices.

She currently sits the California State University, Los Angeles President's Council having been appointed by President William Covino. Ms. Figueroa-Villa has previously served on several commissions and boards, including the City of Los Angeles's Children, Youth and Family Commission, the Los Angeles Unified School District's Redistricting Commission, the Superintendent Search Committee, and the Mia St. John Foundation, and others. She has provided capacity building training to other non-profits and volunteers on community advocacy campaigns.

She is married to Jesus, who retired from the Los Angeles Unified School District. Their daughter, Xochitl, is a student at Cal Poly San Luis Obispo.

Claudia Luna will assist you during the confirmation process if you have questions.
