
FOR COUNCIL CONSIDERATION

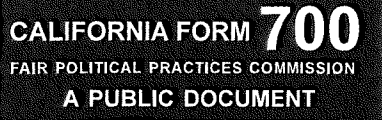
