Since 1984, he has advised candidates and elected officeholders on issues ranging from crisis and press management. environmental insurance, climate, environmental crimes and environmental justice. At LADWP, Mr. Funderburk's activities have included playing some role in: negotiating the Owens Lake dust mitigation settlement, serving on the American Public Power Association Policy Council, developing the LADWP Equity Metrics Data Initiative and initiating innovative stormwater capture strategies.
