

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. PRESENT and ADOPT the Ordinance dated December 3, 2013, relative to amending Article 9.5 of the Los Angeles Municipal Code to make various changes to the City's ethics laws.
- 2. REQUEST the City Attorney to prepare and present a revised Ordinance, substantially in the form as the Ordinance dated December 3, 2013, attached to the Council file, with the following amendment to Sec 49.5.8 (c) (4) b: For all other restricted sources, the applicable gift limit is one hundred dollars (\$100) per calendar year.

<u>Fiscal Impact Statement</u>: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:
