Thank you for allowing me the time to speak to you today. My name is Darrin Gold and I'm a Real Estate Broker and Property OWNER here in downtown Los Angeles. I am also the founder of the Los Angeles Vapers Club. A social and networking group of over 200 members representing Los Angeles and surrounding cities and counties.

I was a smoker for 27 years. I made many attempts to quit during that time. I used the suggested methods including the nicotine patch, nicotine gum, and the nicotine lozenge. Each gave me success for a few weeks but I eventually went back to Traditional cigarettes. On December 17, 2010 I purchased an electronic cigarette and I have been a non smoker ever since. My health has improved greatly since I became a non smoker. I no longer suffer from constant infections or chest congestion. I can climb many flights of stairs without getting winded and I have lost over 50 pounds. If it were not for the electronic cigarette, I would have been a smoker for the rest of my life. I have seen 100's of people in our community switch from **Traditional Cigarettes to Electronic Cigarettes** with the same results.

It is on behalf of myself as a property owner and my members as a vaper that I ask the Council to reject in full the proposed amendments to the Los Angeles Municipal Code as I believe action like this will not only cause harm to the health of the citizens of Los Angeles but also the loss of jobs, revenue to the city and more vacant retail spaces in our properties.

Sending users of Electronic Cigarettes out to the smoking sections will not only increase our health risk, which we have worked so hard to reduce but, may also cause many former smokers back to Traditional Cigarettes.

Should the council decide to vote in the affirmative on this ban, I respectfully request that the following places be specifically exempted from said ban.

Electronic Cigarette shops where the products are sold, People's Apartments where they live, and Outside areas of the City.
