Re: Adoption of E-Cigarette Ordinance

Dear Council Member O'Farrel and Members of the City Council,

The Los Angeles Unified School Districts Beyond the Bell Program works in partnership with the Los Angeles City Attorney's Tobacco Enforcement Program to reduce youth access and use of tobacco products. We value our partnership with the City in developing a strong future for our students, the children of this city. Three months ago we wrote a letter in support of the E-cigarette amendments to the City's Tobacco Retail Permit and Self-Service Display ordinances.

The statistics are well known. The use of E-cigarettes has mushroomed. Usage of Ecigarettes is up more than doubled from year to year. One in 10 High School students said they had tried an e-cigarette in the last twelve months. The big three tobacco companies are buying the business, and in the absence of any form of regulation, quality control, or licensing, vendors are marketing directly to young people. Claims of safety are being made which are completely unverified. This is a totally unregulated product being sold for consumption to the public in the millions. That alone should cause alarm.

Big tobacco is not investing money for the sake of public health. E-cigarettes are not subject to safe manufacturing standards, nor any health control. Cough drops get more scrutiny. Moreover, the primary effect of E-cigarettes is to introduce nicotine into the systems of users. History can be our guide, and we remember that those big three companies once deliberately increased the nicotine dosage of their product to addict their users. Since that is how they acted before we do not trust their assurances now.

We believe that E-cigarettes model behavior that is dangerous and undermines smokefree laws. We believe that E-cigarettes promote addiction. We believe that the use of E-cigarettes in public places normalizes the act of smoking. We also believe that the flood of marketing of E-cigarettes aimed at young people is sinister, intending to addict youthful users under the cover of a false declaration of good intentions and specious pronouncements about what is good for the public health.

We support the proposed ordinance to prohibit the use of E-cigarettes in all areas where the smoking of tobacco products is currently prohibited. The proposed ordinance can play an important role in protecting the health of our youth by reducing the potential for re-normalizing smoking where tobacco use is prohibited and protecting our youth from observing behavior that could encourage them to smoke.
