Responsible for the implementation of ELACC's community development strategy for the Eastside, management of the corporation's day-to day activities, including staff supervision, budgeting, identifying housing development projects, fund development, board development, community building and public relations. During tenure as President, ELACC's revenue has grown from \$500,000 in 1999 to \$2.8 million in 2013 and staff has grown from 5 full-time to 26 full-time and 2 part-time employees. Additionally, ELACC has leveraged over \$135 million in private and public sources for the development of affordable housing. ELACC has developed nearly 500 units of family housing with an additional 110 in construction. ELACC provides homebuyer and financial literacy education, community organizing and community wellness programs. From 2010-2011, served as lead for the Building a Healthy Boyle Heights planning effort, a 30 organization collaborative to develop a 10 year Healthy Community plan for Boyle Heights.



Professional Biography:

Maria Cabildo has spent her career promoting and advancing socially and economically just community development in East Los Angeles, the community where she was born and raised. During her tenure at East LA Community Corporation (ELACC), an organization she co-founded in 1995, ELACC has developed a community development model that fuses grassroots community organizing, contextualized real estate development and asset building to preserve and enhance communities. Over the last ten years, ELACC has captured and invested over \$135 million in affordable housing and community development resources, and organized the participation of hundreds of community residents in development decision making, community planning and anti-displacement efforts. Major projects include the historic Boyle Hotel-Cummings Block, the first transit oriented development on the Metro Gold Line and the Beswick Apartments, the first Veterans housing development to be built on the Eastside of Los Angeles.

Maria is a graduate of the Phillips Exeter Academy. She has a Bachelor of Arts Degree from Columbia University and a Master's Degree in Urban Planning from UCLA. Maria sits on the board of directors of National, State and local organizations, including: National Low Income Housing Coalition (Washington, DC), California Housing Partnership Corporation (San Francisco), Housing California (Sacramento) and the Los Angeles Unified School District Citizen's Construction Bond Oversight Committee.

You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission, 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012.
