Re: <u>Performance Period Extension, Contracting Authorities and Budget Modifications for</u> <u>the Securing the Cities Grant Program (Council File Nos. 13-1301, 13-1301-S1, 13-1301-S2)</u>

Dear Honorable Members:

Transmitted herewith for City Council consideration is the notification of performance period extension and proposed contracting authorities and budget modifications for the Securing the Cities (STC) Grant Program (Council File Nos. 13-1301, 13-1301-S1, 13-1301-S2) from the U.S. Department of Homeland Security (DHS) Countering Weapons of Mass Destruction (CWMD) Domestic Nuclear Detection Office (DNDO). The STC Program is a cooperative grant agreement with a performance period from October 15, 2012 through October 14, 2019.

# Program Background

The STC Program's overarching goal is to prevent nuclear attacks by detecting and interdicting nuclear materials that are out of regulatory control and may be used as a weapon. The STC Program has three main objectives: 1) to enhance regional capabilities to detect, identify and interdict nuclear materials that are out of regulatory control; 2) to guide the coordination of federal, state, and local agencies in their roles as defined by the Global Nuclear Detection Architecture (GNDA); and 3) to encourage participants to sustain nuclear detection programs over time.

The Los Angeles/Long Beach (LA) STC Program continues to coordinate and integrate detection and interdiction of radiological and nuclear materials in the Los Angeles region. Primary Partners include agencies within the disciplines of law enforcement, fire, public health, transit, and maritime. The LA STC Program Primary Partners are the: Los Angeles

Police Department (LAPD), Los Angeles Fire Department (LAFD), Los Angeles Port Police (POLA), Los Angeles World Airports Police Division (LAWA), Los Angeles Sheriff's Department (LASD), Los Angeles County Fire Department (LACOFD), Los Angeles County Department of Public Health (LACDPH), Long Beach Police Department (LBPD), Orange County Sheriff's Department (OCSD), and the California Highway Patrol (CHP). The Mayor's Office of Public Safety (Mayor's Office) serves as the lead agency and program administrator.

On November 5, 2013, the City Council approved the grant's first two budget periods FY 12 and FY 13 (Council File No. 13-1301). On January 7, 2015, the City Council approved the FY 14 award budget and budget modifications for FY 12 and FY 13 (Council File No. 13-1301-S1). On January 19, 2016, the City Council approved the FY 15 award budget and budget modifications for FY 12, FY 13, and FY 14 (Council File No. 13-1301-S1). On April 7, 2017, the City Council approved the FY 16 award budget and budget modifications for FY 12, FY 13, FY 16 award budget and budget modifications and appropriations for FY 12, FY 13, FY 14, and FY 15 (Council File No. 13-1301-S2). On May 2, 2018, the City Council approved the FY 16 performance period extension, budget modifications, and re-appropriation (Council File No. 13-1301-S2).

The total amount of direct grant funding received from DHS DNDO totals \$24,500,000. There is no general fund match requirement for this grant.

### **Project Period Extension**

The LA STC Program is a cooperative grant agreement with a performance period from October 15, 2012 through October 14, 2019. The Mayor's Office submitted a request for a project performance period extension to the Grantor on May 23, 2018, requesting a 12-month extension for all grant projects from all budget periods. The request was approved on May 24, 2018, for a grant performance extension period to October 14, 2019 (Attachment 1) for the LA STC Program. Authority is being requested to accept the grant performance period extension and to amend subrecipient contracts with the new term to October 14, 2019.

### Mayor's Office Budget Modification

Over the course of the grant program, cost savings from within the Mayor's Office equipment allocation were identified. These cost savings were modified into other, previously-approved Mayor's Office equipment projects to include technology enhancements to radiation detection backpack systems deployed throughout Los Angeles region, and to mobile radiation detection systems installed in vehicles and vessel assets throughout the Los Angeles region. These modifications were approved by the Grantor on November 30, 2018. No contracting, fiscal or appropriation authorities are being requested. # Cost Savings

As the Mayor's Office and partner jurisdictions have completed their projects, cost savings totaling \$1,480,839.35 were identified from the following departments:

# Mayor's Office

The Mayor's Office identified cost savings totaling \$1,827.10 from their grant management and administration (M&A) allocation (\$1,627.10) and from their equipment allocation (\$200). These cost savings were reallocated to other previously-approved Mayor's Office projects. The Mayor's Office requests authority to modify the grant budget and conduct the necessary transfer of appropriations, as noted within this report.

# California Highway Patrol (CHP)

The CHP was originally allocated \$790,664 in LA STC grant funding (Contract Number C-125458). Due to challenges completing their trainings, CHP had cost savings totaling \$405,050 for a new allocation of \$385,614. These cost savings were absorbed by the Mayor's Office for STC regional equipment projects and expansion of the STC grant program. The Mayor's Office requests authority to modify the grant budget, conduct the necessary transfer of appropriations, and negotiate and execute a contract amendment with the CHP.

# Los Angeles County Fire Department (LACoFD)

The LACoFD was originally allocated \$182,464 in STC grant funding (Contract Number C-125914). Due to personnel training challenges, LACoFD was unable to spend any LA STC funding and returned the entire STC grant funding allocation in the amount of \$182,464 to the Mayor's Office. These cost savings were absorbed by the Mayor's Office for STC regional equipment projects and expansion of the STC grant program. The Mayor's Office requests authority to modify the grant budget, conduct the necessary transfer of appropriations, negotiate and execute a contract amendment with LACoFD and negotiate and execute a memorandum of agreement for their continued use of STC equipment, as well as participation in the STC Program, for a term ending no later than October 14, 2019.

# Los Angeles Sheriff's Department (LASD)

The LASD was originally allocated \$776,165 in LA STC grant funding (Contract Number C-125911). Due to challenges completing their trainings, LASD had cost savings totaling \$370,779.72 for a new allocation of \$405,385.28. These cost savings were absorbed by the Mayor's Office for STC regional equipment projects and expansion of the STC grant program. The Mayor's Office requests authority to modify the grant budget, conduct the necessary transfer of appropriations, and negotiate and execute a contract amendment with the LASD.

# Orange County Sheriff's Department (OCSD)

The OCSD was originally allocated \$966,565 in LA STC grant funding (Contract Number C-124772). Due to challenges completing their trainings, OCSD had cost savings totaling

\$520,718.53 for a new allocation of \$445,846.47. These cost savings were absorbed by the Mayor's Office for STC regional equipment projects and expansion of the STC grant program. The Mayor's Office requests authority to modify the grant budget, conduct the necessary transfer of appropriations, and negotiate and execute a contract amendment with the OCSD.

# **Budget Modifications from Cost Savings**

In order to fully expend these funds within the grant performance period, funds were reallocated to various approved projects as noted below. The Grantor approved these modifications on November 30, 2018.

### Los Angeles Police Department (LAPD)

Due to changes in the increased detection capability of the CHP from the state-level, 350 personal radiation detection (PRD) devices previously allocated to the CHP were transitioned to the LAPD. Associated PRD training and training funds in the amount of \$251,676.57 were modified from partner jurisdiction returned funds to LAPD in support of this built capability.

### Mayor's Office

A total of \$1,057,187.94 was reallocated to the Mayor's Office. Due to the nature of secondary screening response capabilities, secondary screening teams utilize radio-isotope identifying devices (RIIDs) capable of classifying precise elements utilizing laptop computers with connectivity to send back detection spectrum information from the device for additional analysis to the Department of Energy's Radiological Triage Center. \$540,558 was modified from partner jurisdiction returned funds to purchase 30 additional RIIDs. \$516,629.94 was allocated to LA Region equipment for future expansion and ongoing equipment costs and Radiation Safety Officer (RSO) training as approved by the Grantor.

### Riverside Police, Riverside Fire, and Ontario Fire Departments

The LA STC program is currently in process of expansion—new agencies have been approved by the Mayor's Office program administrators in collaboration with the Grantor. \$168,780 from partner jurisdiction returned funds has been set aside to support the STC program as it continues to reach out to additional Southern California partners outside of Los Angeles and Orange and for additional preventive radiation and nuclear detection equipment for the program. At this time, the Mayor's Office has obtained letters of intent and support from the Riverside Police Department, Riverside Fire Department, and Ontario Fire Department as new program partners to extend the prevention mission of the program to encompass areas outside of the Los Angeles region (Attachments 2-4). The inclusion of these three jurisdictions will expand the LA STC program footprint to a wider area of coverage and the greater likelihood of prevention and interdiction of illicit source material from entering the Los Angeles region. \$56,260 is allocated to each expansion partner for training and exercise in accordance with the LA STC Program, in the total amount of \$168,780.

Authority is requested to contract with Riverside Police Department, Riverside Fire Department, and Ontario Fire Department to provide preventive radiological and nuclear detection equipment (including, but not limited to, personal radiation detectors and radioisotope identifying devices) and training and exercise funding in the amount of \$56,260 each, for first responder training overtime and backfill.

### Long Beach Police Department (LBPD)

The LBPD was originally allocated \$418,663.00 in LA STC grant funding (Contract Number C-124773). Due to RSO training needs, an additional \$3,194.84 was directed to LBPD for a total contract amount of \$421,857.84. The Mayor's Office requests authority to modify the grant budget and negotiate and execute a contract amendment with the LBPD.

# **Reappropriations**

### LAFD and LAPD

Public safety personnel are trained on the use of radiological detection equipment prior to being deployed in the field with STC equipment. The primary screener course trains participants to perform basic preventive radiological/nuclear detection operations as primary screeners employing a PRD. The project period extension allows for LAPD and LAFD to continue sending responders to training courses and exercises on overtime and backfill as overtime to grantor-approved sessions.

Authorization is requested to reappropriate \$216,576.63 for LAFD salaries and \$307,861.81 for LAPD, both amounts are comprised of FY 12, 13, 14, 15, and 16 unexpended funds for Grantor approved training.

### Mayor's Office

Grant M&A costs cover the salaries and fringe benefits for one program manager, one contract specialist, one grant specialist, one accountant, and part-time for one grants director. These positions continue to handle day-to-day operations and coordination for the LA STC program.

Authorization is requested to reappropriate \$183,200.84 in Mayor's Office fringe benefits.

### **RECOMMENDATIONS**

It is therefore requested that the City Council:

- 1. AUTHORIZE the Mayor, or designee, to:
  - a. Modify the existing grant budget for the STC grant by reallocating funds between projects as described in this report;

- Approve the time extension of the Fiscal Year 2016 Securing the Cities grant award and continued carryover of funding from all approved budget periods (Fiscal Years 2012, 2013, 2014, 2015, and 2016), extending the grant performance period to October 14, 2019;
- c. Execute amendments to existing memorandum of agreements with the Port of Los Angeles and Los Angeles World Airports to extend the term of the subrecipient agreements to October 14, 2019, subject to the approval of the City Attorney as to form;
- d. Execute an amendment to the existing subrecipient agreement with Los Angeles County Department of Public Health (LACDPH), to extend the term of the subrecipient agreement to October 14, 2019, subject to the approval of the City Attorney as to form;
- e. Negotiate and execute a contract amendment with the California Highway Patrol to decrease their total contract amount by \$405,050.00, from the previous authorized amount of \$790,664.00 for a new contract amount of \$385,614.00, and extend the term of the subrecipient agreement to October 14, 2019, subject to the approval of the City Attorney as to form;
- f. Negotiate and execute a contract amendment with the Orange County Sheriff's Department to decrease their total contract amount by \$520,718.53, from the previous authorized amount of \$966,565.00 for a new contract amount of \$445,846.47, and extend the term of the subrecipient agreement to October 14, 2019, subject to the approval of the City Attorney as to form;
- g. Negotiate and execute a contract amendment with the Los Angeles Sheriff's Department to decrease their total contract amount by \$370,779.72, from the previous authorized amount of \$776,165.00 for a new contract amount of \$405,385.28, and extend the term of the subrecipient agreement to October 14, 2019, subject to the approval of the City Attorney as to form;
- h. Negotiate and execute a contract amendment with the Long Beach Police Department to increase their total contract amount by \$3,194.84, from the previous authorized amount of \$418,663.00 for a new contract amount of \$421,857.84, and extend the term of the subrecipient agreement to October 14, 2019, subject to the approval of the City Attorney as to form;
- i. Negotiate and execute a contract amendment with the Consolidated Fire Protection District of Los Angeles County to decrease their entire contract amount of \$182,464, and negotiate and execute a memorandum of understanding (MOU) for their continued use of STC equipment and participation in the STC Program, for a term ending no later than October 14,

2019, and authorize the Mayor, or designee, to execute such MOU, subject to the approval of the City Attorney as to form and legality; and

- j. Execute subrecipient agreements, subject to the approval of the City Attorney as to form and legality, for the distribution of STC Grant funds in the amount of \$56,260.00 each, and in accordance with the budget allocations for Fiscal Years 2018-19 as approved by the Grantor, for a term of up to 12 months but ending no later than October 14, 2019 with the following LA STC Program Expansion Participants: Riverside Police Department, Riverside Fire Department, and Ontario Fire Department.
- 2. AUTHORIZE the Controller to:
  - a. Transfer appropriations and create new appropriations within Fund **55X/46**, **STC** as follows:

This letter confirms the Riverside Police Departments commitment to participate in the Securing the Cities (STC) program to enhance nuclear detection capabilities in the Los Angeles region and surrounding jurisdictions.
