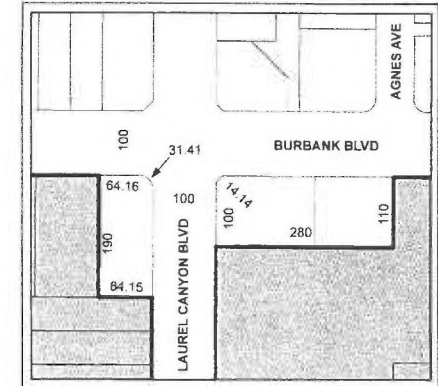
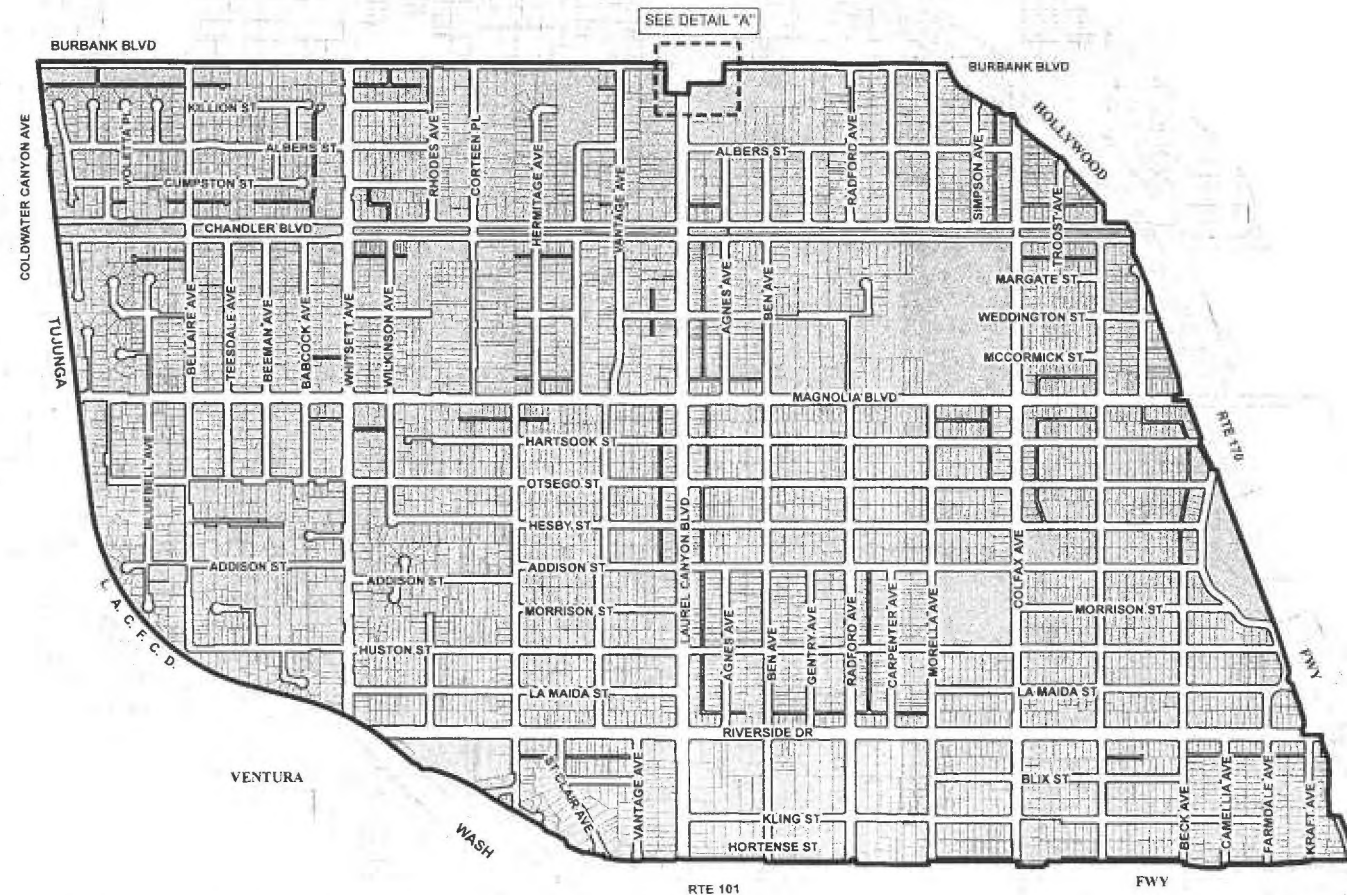


ORDINANCE NO. 183735

DO ORDAIN AS FOLLOWS:**

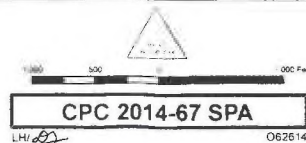
Section 1. The Specific Plan Boundary Map of the Valley Village Specific Plan (Ordinance No. 168,613) is amended to read as follows:

DECLARATION OF POSTING ORDINANCE


