2. AUTHORIZE the General Managers of the departments identified in the table above, or designees, to make any technical changes and prepare any necessary Controller instructions that may be required to effectuate the intent of this action, subject to the approval of the Chief Legislative Analyst (CLA); and, AUTHORIZE the Controller to implement said instructions.
3. AUTHORIZE the General Managers of the departments identified in the table above, or designees, to negotiate and execute amendments to the current contracts through June 30, 2015 to effectuate the intent of this action, subject to the approval of the City Attorney as to form.
4. AUTHORIZE the General Manager, Los Angeles Housing and Community Investment Department, or designee, to amend the 40th Program Year Consolidated Plan to reflect the revised Community Development Block Grant allocations as follows:

5. TRANSFER \$150,000 from the Vision Theatre Project CIEP 13-14 Account 100/54 to the Economic and Workforce Development Department (EWDD) for the Armenian Relief Society to be replaced with future Municipal Improvement Corporation of Los Angeles funds.
6. INSTRUCT the EWDD to:

- a. Amend the contract with the Armenian Relief Society to reflect the new funding.
- b. Prepare Controller instructions as needed.
- c. Make any necessary technical changes to reflect this action.

SUMMARY

At a special meeting held on May 27, 2014, the Housing Committee considered Motion (Wesson - Cedillo) relative to transferring \$9,192,505 in Capital Improvement Expenditure Program funds from various capital improvement projects to Community Based Development Organization programs that did not receive CDBG funding in the recently adopted 40th Program Year (2014-15) Consolidated Plan budget.

At the request of the Council President, the Committee amended the recommendations in the Motion to transfer \$150,000 from the Vision Theatre Project CIEP account to the EWDD for the Armenian Relief Society and to amend the contract with this organization to reflect the new funding.

After providing an opportunity for public comment, the Committee approved the recommendations in Motion (Wesson - Cedillo) as amended. This matter is now forwarded to the Council for its consideration.
