

2. AUTHORIZE the Director, BOS, or designee, to accept the USEPA Brownfield Grant Funds FY14 in the amount of \$400,000.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies to or pending before a local, state or federal government body or agency must have been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, United States Environmental Protection Agency (USEPA) provides Grants for investigation and cleanup of contaminated properties to assist in sustaining and restoring communities; and

WHEREAS, the City of Los Angeles has long recognized that it is in the public interest to establish, implement and maintain USEPA funds to promote the cleanup and revitalization of contaminated properties; and

WHEREAS, On December 17, 2013, the City Council authorized the Bureau of Sanitation (Sanitation) to submit a Brownfield Grant Application FY14 to the USEPA for community area-wide assessment and cleanup funds (for up to \$600,000) in Los Angeles to fund Brownfield environmental services (Council File No. 13-1468); and

WHEREAS, On January 16, 2014, Sanitation submitted the Brownfield Grant Application FY14 to the USEPA; and

WHEREAS, On May 28, 2014, Sanitation received notice of award of the USEPA Brownfield Assessment Grant FY14 for \$400,000.

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Los Angeles does hereby authorize the Director of the Bureau of Sanitation, or designee, to accept, negotiate and execute all necessary agreements with the USEPA to implement and carry out the purposes specified in the application.
