

We, Robin Greenberg and Nickie Miner, declare that we are the President and Vice President respectively of the Bel Air Beverly Crest Neighborhood Council, and that on March 23, 2016, a Brown-Act noticed public meeting was held by the Bel Air Beverly Crest Neighborhood Council with a quorum of 15 met, and the Bel Air Beverly Crest Neighborhood Council unanimously approved, by 22 yeas, 0 nays, 0 abstentions, **amending the Small Lot Subdivision Ordinance such that "all Small Lot Subdivision projects shall comply with the land's underlying zone, including setbacks."**
