Find after consideration of the whole of the administrative record, including the Negative Declaration No. ENV-2019-4121-ND (Negative Declaration) and any comments received, there is no substantial evidence the Project will have a significant effect on the environment; and the Negative Declaration reflects the City Council's independent judgment and analysis; and adopt the Negative Declaration No. ENV-2019-4121-ND. 2. Determine, that based on the whole of the administrative record, that the proposed resolution and ordinance is not a project under CEQA pursuant to Section 15378(b)(5) of the California Public Resource Code and that the Project is exempt from CEQA pursuant to CEQA Guidelines, Sections 15308 and 15320, and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies. 3. Adopt the Resolution transferring the land use authority from the CRA/LA-DLA to the City of Los Angeles. 4. Adopt the Ordinance establishing procedures implementing the Redevelopment Plans and other amendments to the Los Angeles Municipal Code to facilitate the transfer of land use authority from CRA/LA-DLA. 5.
