

The remaining funding in the amount of \$20,205,366 will be requested in future fiscal year's Bureau of Sanitation operating budget.

DISCUSSION

Background

The City of Los Angeles, Bureau of Sanitation (Bureau) provides curbside collection of green material to approximately 750,000 single-family residences and small multi-family complexes (comprised of four units or less). Maintaining the green material program allows the City to meet California's Integrated Solid Waste Management Act (AB939) requirements, and contributes toward the achievement solid waste diversion goal by 2013.

On a daily average basis, the Bureau collects approximately 1,800 tons of green material from City residents. The majority of the collected green material is delivered to privately-owned processing facilities, such as WM and CRRR. The remaining green material is delivered to City-owned Harbor Mulching Facility and Lopez Canyon Environmental Center. Currently, WM processes about 1,000 tons per day (tpd) of residential green material at their Bradley facility in Sun Valley, and about 220 tpd at their Metro transfer station in Los Angeles. CRRR processes 400 tpd of residential green material at their Sun Valley facility.

In September 2002, the City released a Request for Qualification (RFQ) to identify interested and qualified parties to provide "all inclusive" turnkey recycling services for the receipt, processing, and reuse of green material (yard trimmings and horse manure) collected through the City's Curbside Collection Program. Five (5) respondents were deemed qualified by the City. These were Waste Management, Community Recycling & Resource Recovery, Ecologics, Brown & Ferris Industries, and BLT Enterprises.

In March 2003, the City issued a Request for Bids (RFB) to the five (5) qualified parties to receive, process, and reuse residential green materials. All five (5) submitted bids. Waste Management Bradley Landfill and Recycling Center (WM) and Community Recycling & Resource Recovery (CRRR) were deemed to be the most qualified respondents as determined through the evaluation criteria stated in the RFB.

On May 26, 2004, the Board approved and forwarded a report to the Mayor and the City Council with the request that the Board be authorized to execute personal services contracts with WM and CRRR each for a term of three (3) years with two (2) three (3) year renewal options (Transmittal 1).

On October 14, 2004, Contract C-107485 with WM and Contract C-107486 with CRRR were fully executed. In 2007, the City exercised its first three (3) year renewal option for both contractors. In 2010, the City exercised its second and final three (3) year renewal option for both contractors (Transmittals 2, 3, 4 and 5). These contracts will expire on October 13, 2013.

The Bureau has recently distributed a Request for Proposal (RFP) and is currently evaluating the submitted proposals for the processing of green material, food material, and horse manure. The most qualified proposer(s) will be awarded the new contract(s). The new contract(s) will not be fully executed before the existing contracts expire. Therefore the Bureau is processing Supplemental Agreements to the WM and CRRR contracts. These Supplemental Agreements will enable the Bureau to continue providing the City residents with uninterrupted, critical and essential green material collection and processing services. Such services cannot be abruptly stopped as it will greatly affect the solid waste collection operations, which may lead to potential public health and environmental issues. It is the City's desire to retain WM and CRRR through execution of these Supplemental Agreements to provide the required professional and technical services specified in their original contracts and subsequent amendments.

The Supplemental Agreements will extend the existing contracts C-107485 and C-107486 for a term of two (2) years from October 14, 2013 to October 13, 2015 (Transmittal 6).

MBE/WBE/OBE Subcontractor Outreach Program

At the time of distribution of the RFB this contract, the City had established an MBE/WBE/OBE Subcontractor Outreach Program for this project with anticipated MBE and WBE participation levels of 12 percent and 5 percent, respectively. When the contract was awarded, the pledged participation levels for CRRR contract C-107486 were 0% MBE, 0% WBE, and 12.86% OBE. For Amendment 1, the pledged participation levels were 0.16% MBE, 0% WBE, and 10.75% OBE. For Amendment 2, the pledged participation levels were 0.08% MBE, 0% WBE, and 9.32% OBE. As of June 15, 2013, the achieved participation levels were 0.11% MBE; 0% WBE, and 5.25% OBE. Upon approval of this Supplemental Agreement, the pledged participation levels will be 0.09% MBE, 0% WBE and 4.39% OBE.

CRRR has exceeded its Amendment 2 pledged MBE participation level. However, CRRR has not been meeting their Amendment 2 OBE participation level. This level has decreased due to recent significant increases in diesel fuel costs coupled with lower processing volumes hindering the amount of subcontracting work. Therefore, for the Supplemental Agreement CRRR is pledging a more realistic OBE participation level.

At the time of distribution of the RFB for this contract, the City had established an MBE/WBE/OBE Subcontractor Outreach Program for this project with anticipated MBE and WBE participation levels of 12 percent and 5 percent respectively. When the contract was awarded, the participation levels for WM contract C-107485 were 14.94% MBE, 0% WBE, and 0% OBE. For Amendment 1, the pledged participation levels were 18.63%MBE, 0% WBE, and 0% OBE. For Amendment 2, the pledged participation levels were 13.54% MBE, 0% WBE, and 3.82% OBE. As of June 15, 2013, the achieved participation levels were 14.38% MBE, 0% WBE, and 0.26% OBE. Upon approval of this Supplemental Agreement, the pledged participation levels will be 13% MBE, 0% WBE, and 1% OBE.

Although WM has been exceeding their Amendment 2 MBE participation pledged levels, they have not been meeting their Amendment 2 OBE participation levels becausethey had over anticipated the use of these subcontractors. For the Supplemental Agreement, WM has adjusted both the MBE and OBE participation levels to reflect more realistic achievable levels in the next two years.

Term and Value of Contracts

The term of the Supplemental Agreement with WM will be for two (2) years from October 14, 2013 to October 13, 2015. The estimated total cost to pay for the Contractor's services for two (2) years under this Supplemental Agreement shall not exceed \$35,858,000.

The term of the Supplemental Agreement with CRRR will be for two (2) years from October 14, 2013 to October 13, 2015. The estimated total cost to pay for the Contractor's services for two (2) years under this Supplemental Agreement shall not exceed \$11,764,000.

These Supplemental Agreements may be terminated by the City if new contracts for similar services are fully executed before October 13, 2015.

Contractor Responsibility Ordinance

All Contractors participating in this program are subject to compliance with the requirements specified in the City of Los Angeles' Contractor Responsibility Ordinance #173677, [Article 14, Chapter 1, Division 10, L.A.C.C.]. Failure to comply with requirements specified in this Ordinance will render the contracts subject to termination pursuant to the conditions expressed therein.

Contractor Performance Evaluation Ordinance

In accordance with Article 13, Chapter 1, Division 10 of the City of Los Angeles Administrative Code, the appropriate City Personnel responsible for the quality control of these Personal Services Contracts shall submit Contractor Performance Evaluation Reports to the City Administrative Officer (CAO) upon completion of these contracts.

Contract Administration

Responsibility for administration of these Supplemental Agreements will be with the Solid Resources Support Services Division, Bureau of Sanitation.

Headquarters and Work Force Information

The headquarters of WM is located at 9081 Tujunga Avenue, Sun Valley, CA 91352. The Contractor has a staff of 98 full-time employees assigned to this contract and 23% of the employees reside within the City of Los Angeles.

The headquarters of CRRR is located at 9189 DeGarmo Avenue, Sun Valley, CA 91352. The Contractor has a staff of 235 full-time employees assigned to this contract and 64% of the employees reside within the City of Los Angeles.

City Attorney Review

The proposed Supplemental Agreements have been approved as to form by the Office of City Attorney.

STATUS OF FINANCING

The cost estimate for the services required from Waste Management (WM) will be \$35,858,000. Funds for the first fiscal year estimated cost of \$15,652,634 will be funded by Solid Resources Support Services (SRSSD) Adopted Budget for FY 13-14 in Fund 508, Dept. 50, Account 50KX82, Object 602. The remaining funding in the amount of \$20,205,366 will be requested in future fiscal year's Bureau of Sanitation operating budget.

The cost estimate for the services required from Community Recycling and Resource Recovery (CRRR) will be \$11,764,000. Funds for the first fiscal year estimated cost of \$5,217,545 will be funded by Solid Resources Support Services (SRSSD) Adopted Budget for FY 13-14 in Fund 508, Dept. 50, Account 50KX82, Object 602. The remaining funding in the amount of \$6,546,455 will be requested in future fiscal year's Bureau of Sanitation operating budget.

The contracts contain a "Financial Liability Clause" which states that "the City's liability under this contract shall only be to the extent of the present City appropriation to fund the contracts. However, if the City shall appropriate funds for any succeeding years, the City's liability shall be extended to the extent of such appropriation, subject to the terms and conditions of the contracts."

FISCAL IMPACT STATEMENT

The unit rates offered by the proposed contractors are less than the current contract rates paid by the City for green waste processing services. In addition, under these contractual arrangements, on-route collection time in the West Los Angeles and North Central wastesheds will increase by eliminating the longer haul times through the use of the contractors' local facilities. It is anticipated that the award of these contracts will result in a savings to the General Fund.

DISCUSSION

Background

The City of Los Angeles, Bureau of Sanitation, services over 740,000 single-family residences and small apartment complexes and collects approximately 1,800 tons of green material per day. The curbside green material collection program continues to be the single largest contributor to the City's curbside diversion effort as mandated by AB939, contributing over 435,948 tons of material which is source separated by the City residents and collected by Sanitation staff. The majority of this material is processed through contracts with several private companies that prepare the material for hauling and processing at various reuse and distribution sites.

The City of Los Angeles, Bureau of Sanitation, Solid Resources Division (SRSSD) solicited Services proposals contractors to provide "all-inclusive" turnkey recycling services for the receipt, processing and reuse of green material (yard trimmings and horse manure) collected through the City's Curbside Collection The recycling services to be provided by the selected contractor include the designation of a local drop-off (transfer) site, removal of contamination from the green material, handling, transporting and disposing of the contaminants at a City designated solid waste facility. The selected contractor will also provide green material processing operations consisting of but not limited to chipping and grinding, composting, and co-composting. Processing of the green material including marketing, transporting, and delivering the final product to end-users will be arranged and designated by the contractor.

Two-Phase Procurement Process

The Bureau of Sanitation initiated a two-phase procurement process in order to find the best contractor(s) capable of handling the City's green material. Phase One was the Request for Qualifications (RFQ) where interested companies submitted proposals to demonstrate their qualifications. The intent of the RFQ was to establish a short list of pre-qualified contractors who would then be eligible to participate in Phase Two. Phase Two is the Request for Bids (RFB) process where only the pre-qualified contractors as determined in

Phase-One are eligible to participate. The successful bidder will be determined by whoever has the lowest responsive bid.

Phase One - Request for Qualification (RFQ)

On September 23, 2002, the Board of Public Works authorized the Bureau to distribute the Request for Qualifications (RFQ). Five (5) vendors: BLT Enterprises, Browning & Ferris Industries, Community Recycling, Ecologics, and Waste Management participated. The Bureau deemed all vendors to have successfully met the qualifications criteria and were recommended to proceed to the Request for Bid (RFB) process. On March 10, 2003, the Board of Public Works approved the list of pre-qualified contractors and authorized the Bureau of Sanitation to release the RFB.

Phase Two - Request For Bids (RFB)

The Bureau of Sanitation released the RFB to the qualified proposers as determined through the RFQ process, namely: Waste Management Recycling, Ecologics, Community Recycling, Browning & Ferris On May 23, 2003, the bids were Industries and BLT Enterprises. opened and read at the regular meeting of the Board of Public Works. Waste Management was the lowest responsive bidder for the Valley and Metro service areas. Ecologics was the lowest responsive bidder for the Western service area. The bid results are shown in the table below. All bidders have designated local drop-off (transfer) sites, where they will remove contamination from the green material, and, will handle, transport and dispose of the contaminants at a designated solid waste facility. The selected bidders will also provide green material processing operations consisting of but not limited to chipping and grinding, composting, and co-composting. Processing of the green material including the marketing, transporting, and delivering the final product to end-users will be arranged and designated by the contractor.

In the last two (2) years, several green material processors, utilized by the City were forced to shutdown due to environmental regulations, weather conditions, regulatory actions, market shifts, etc.

The City needs to have Community Recycling as a secondary contractor for green material processing to address any service interruptions. In addition Community Recycling will be utilized to absorb any seasonal increases in green material that cannot be handled by the primary contractor.

Through the RFB process the City reserved the right to award multiple contracts to maintain a reliable green material recycling program. On this basis, Community Recycling has also been selected for award of a contract.

Proposed Term of Contract

The proposed term of the contract will be three years, with (2) two 3-year contract renewal options for potential total contract term of nine (9) years, to be exercised at the sole discretion of the City. Execution of the contract requires Council Approval because of the potential total term is for nine (9) years. The execution of future contract renewal options shall not require City Council approval.

City Requirements

The selected vendor shall comply with all City of Los Angeles requirements including:

- o Nondiscrimination/Equal Employment Practices/Affirmative Action
- o Insurance/Bonding Requirements
- o Business Tax Registration Certificate
- o Child Care/Support Policy

DISCUSSION

Background

The City of Los Angeles, Bureau of Sanitation provides curbside collection of green material to approximately 750,000 single-family residences and small multi-family complexes of four (4) units or less. On a daily average, the Bureau collects approximately 1,700 tons of green material from these customers. The collected green material is sent to both City-owned and privately-owned processing facilities for mulching and composting.

In October 2004, the Bureau established a contract with Waste Management for the receipt, transfer, processing, and beneficial reuse of residential green material (yard trimmings and horse manure) from the Valley and Metro areas. The contract required that Waste Management receives no less than 100 tons of green material per day with a contamination level of up to 50 percent (by volume), provide a transfer site, and remove and dispose of contamination prior to further processing.

Proposed Term of Renewal Contract

On May 26, 2004, the Board approved a personal services contract (Transmittal 1) with Waste Management – Bradley Landfill and Recycling Center for a term of three (3) years with two (2) three (3) year renewal options for a potential total contract term of nine (9) years. Following the end of the first term on October 13, 2007, the contract was renewed for another three (3) year term which will expire on October 13, 2010. Council approval is not required for the execution of the second three (3) year term or the final three (3) year term, since the original Council approval on October 14, 2004 included the renewal options. Waste Management satisfactorily complied with all the contract requirements and therefore, the Bureau recommends extending the contract for another three (3) year term. The new contract term will be from October 14, 2010 through October 13, 2013.

Changes to the Contract

With the proposed Amendment No. 2 (Transmittal No. 2) the Bureau is proposing changing the rate schedule and tonnage delivery limits of green material for both Waste Management facilities serving the Metro and Valley areas (see Tables 1 and 2). The unit cost for the processing of contaminants was reduced by approximately 33 percent. The change in tonnage thresholds as well as the cost reduction in processing contaminants will therefore result in lowering the overall contract cost.

This proposed Amendment No. 2 will also provide the City with the option of utilizing the Waste Management - Waste Transfer and Recycling Center Metro facility (WTR) on an "asneeded" basis, provided the City gives Waste Management a minimum forty eight (48) hour notice of its intent to use WTR. There will be no minimum tonnage requirement and no billing cycle commitment associated with the use of WTR.

This proposed Amendment No. 2 will also remove the residential weekend drop-off service because the City has not used this service at all, it will also add Ecology Auto Parts as a trucking subcontractor.

In addition, this proposed Amendment No. 2 will reduce the pledged MBE participation level from 18.63 percent to 13.28 percent.

Notification of Intent to Contract

The required Notification of Intent to Contract was filed with the CAO Clearinghouse on April 8, 2010.

Charter Section 1022

On July 12, 2010, the Office of the City of Administrative Officer (CAO) determined that the work proposed to be contracted can be performed more feasibly by a contractor than by City employees. The CAO findings indicate there is insufficient City staff to perform the proposed green material processing service and additional staff cannot be employed and trained in a timely manner to meet the Bureau's needs.

MBE/WBE/OBE Subcontractor Outreach Program

The City established an MBE/WBE/OBE Subcontractor Outreach Program for this contract with anticipated MBE and WBE participation levels of 12 percent and 5 percent, respectively. When the contract was awarded, the pledged participation levels were 14.94 percent MBE, 0.00 percent WBE, and 0.00 percent OBE. For Amendment No. 1, the pledged participation levels were 18.63 percent MBE, 0.00 percent WBE, and 0.00 percent OBE. As of June 30, 2010, Waste Management has achieved participation levels of 16.92 percent MBE, 0.00 percent WBE, and 0.00 percent OBE. Upon approval of Amendment No. 2, the pledged participation levels will be 13.28 percent MBE, 0.00 percent WBE, and 3.97 percent OBE.

Under the proposed Amendment No. 2, Ecology Auto Parts will be added as a hauling subcontractor as a backup to Gandara Transport. Waste Management informed the City that it had conducted an outreach to MBE/WBE/OBE transportation companies (Transmittal No. 3) and added Ecology Auto Parts to the City's list of approved green material haulers. Out of the six (6) companies that WM contacted, three (3) haulers submitted a bid. Among the three (3) bids received, Ecology Auto Parts, offered the lowest hauling rate and met Waste Management's green material hauling requirements.
