Re: CF 13-1493 - Sidewalk Vending Policy

Dear Honorable Members:

As long time property owners of 5 buildings along Los Angeles Street, in the Fashion District, we would like to make our opinions known regarding the upcoming Sidewalk Vending Policy vote.

Although this is definitely not the perfect solution, in our opinion, we request that the policy include the following provisions:

- 1. That the vendors need to get WRITTEN PERMISSION from the PROPERTY OWNERS (NOT from the tenants/businesses of the property) before they can sell their wares. Having the permission in writing will allow everyone involved to quickly see if the vendors are allowed to be stationed in certain spots. Without the written permission of the PROPERTY OWNERS, NOT the tenants/businesses, the rules can be quickly and accurately enforced
- 2. There should be NO APPEAL process...if the PROPERTY OWNER SAYS NO, than that is it!!! No appeals will be allowed, under any circumstance. Again, this will be a clear way to follow the regulations.
- 3. We feel that there needs to have ENFORCEMENT services. Without this, the whole policy is worthless. Street Services/police should be given additional funding to provide enforcement...both to levy penalties AND to confiscate property if vendors refuse to comply. Additionally, where there are BID's, their safety teams should be afforded the ability to write up penalty notices, and then allow street services to confiscate.

What we are asking for only partially helps with this enormous problem. As property owners, we need to be able to help our struggling tenants make a living, without having street vendors, who don't pay rent or overhead, complicate an already acrimonious situation.
