

The City Council ADOPTED the following recommendation(s) relative to establishment of the Arts District Los Angeles Property and Business Improvement District (BID), scheduled pursuant to Council action of Tuesday, February 25, 2014 and adoption of Ordinance No. 182826 on December 17, 2013, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the accompanying ORDINANCE establishing the Arts District Los Angeles Property and Business Improvement District and confirming the assessments to be levied upon properties within the BID, as described in the Management District Plan.
2. AUTHORIZE the City Clerk, subject to the approval of the City Attorney, to prepare, execute and administer an operating agreement between the City and the Arts District Los Angeles Non-Profit Corporation for administration of the BID.
