ORDINANCE NO. 185538

An ordinance amending Section 49.95 of the Los Angeles Municipal Code to establish a new sunset date of December 31, 2020, for the Foreclosure Eviction Ordinance and adding a severability clause.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. Section 49.95 of Article 14.1 of Chapter IV of the Los Angeles Municipal Code is amended to read as follows:

SEC. 49.95. SUNSET PROVISION.

The provisions of this Article shall be in effect through December 31, 2020, unless the City Council acts by ordinance to amend this Section to extend its effective period.

Sec. 2. A new Section 49.96 is added to Article 14.1 of Chapter IV of the Los Angeles Municipal Code to read as follows:

SEC. 49.96. SEVERABILITY.

If any provision of this Article is found to be unconstitutional or otherwise invalid by any court of competent jurisdiction, that invalidity shall not affect the remaining provisions of this Article which can be implemented without invalid provisions, and to this end, the provisions of this article are declared to be severable. Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
