### <u>NOTICE OF PUBLIC HEARING</u> <u>RESOLUTION OF NECESSITY</u> <u>TO ACQUIRE PROPERTIES (LISTED ON ATTACHMENT A) BY EMINENT DOMAIN</u> <u>FOR THE BARREN RIDGE RENEWABLES TRANSMISSION PROJECT</u>

NOTICE IS HEREBY GIVEN THAT, in accordance with California Code of Civil Procedure section 1245.235, the City Council of the City of Los Angeles will hold a public hearing on <u>UCT & 2014</u> at 10:00 AM], or as soon thereafter in the John Ferraro Council Chamber, Room 340, City Hall, 200 North Spring Street, Los Angeles, California 90012, to consider the City of Los Angeles' intent to adopt an Ordinance approving the Los Angeles Department of Water and Power's Resolution of Necessity finding that the public interest and necessity require the Barren Ridge Renewables Transmission Project ("BRRTP") and authorizing the acquisition of certain property by eminent domain.

You have the right to appear and be heard on the matters referred to in California Code of Civil Procedure section 1240.030 and all matters affecting the adoption of a Resolution of Necessity to exercise the power of eminent domain, including but not limited to, whether:

- a) the public interest and necessity require the BRRTP;
- b) the BRRTP is planned or located in the manner that will be most compatible with the greatest public good and least private injury;
- c) the properties (identified in Attachment A) sought to be acquired are necessary for the BRRTP;
- d) the offers required by California Government Code section 7267.2 have been made to the owners of record; and
- e) the requisite environmental review for the BRRTP has been conducted and certified by the Board consistent with the California Environmental Quality Act (CEQA).

Questions regarding the amount of compensation to be paid for the properties are not part of this proceeding, but may be discussed with the LADWP's Land Agent identified in your offer letter.


