Appointment of Dallas D. Fowler to the Commission on the Status of Women

FOR COUNCIL CONSIDERATION

Dear Councilmembers:

On December 2, 2013, the Mayor transmitted to the City Clerk a letter indicating his appointment of Ms. Dallas Fowler to the Commission on the Status of Women. The Ethics Commission received Ms. Fowler's pre-confirmation statement of economic interests (SEI) on December 9, 2013, and this letter is provided for your consideration as part of the confirmation process. A copy of this letter is also being provided to Ms. Fowler to help her avoid potential conflicts of interests that may arise in the course of her tenure as a member of Commission on the Status of Women.

Ms. Fowler reports on her SEI her ownership interest in and income from Daltek Global Solutions, LLC. If a matter involving this interest comes before the Commission on the Status of Women, Ms. Fowler should, before acting, seek the advice of the City Attorney regarding whether she should disqualify herself. We are unable to assess if or how frequently Ms. Fowler would be in a position of having to recuse herself.

Interests disclosed on an SEI are not the only interests that can give rise to a conflict of interests. For example, state law may require recusal by a board or commission member due to certain business activities of the clients of that member's employer. Additionally, recusal may be required under City Charter § 222, which states that the City Attorney may provide a written opinion concerning the obligation of a City official to refrain from acting on a matter when it may violate state law or when action may not be in the public interest.

If a matter raises a potential conflict of interests, we encourage Ms. Fowler to seek the advice of the City Attorney before acting. If Ms. Fowler is required to disqualify herself from acting on a matter, Los Angeles Municipal Code § 49.5.6(J) and Executive Directive 2005-1 require her to file a Recusal Notification Form (CEC Form 51) with the Ethics Commission and the Mayor's office. If a board or commission member is disqualified from acting on three or more agenda items in a year because of a conflict caused by the same interest, the Ethics Commission is required by City Charter § 707 to review the conflict. If the Ethics Commission

determines that the member has a significant and continuing conflict of interests, it must order divestment of the interest that is causing the conflict.

In addition to filing SEIs, nominees also file Residence Verification Forms. We have received a completed form from Ms. Fowler, which states that she is registered to vote in the City.
