

Recommendation for Council action:

ADOPT the proposed amendments to Schedules A and B of the conflict of interests code for the Convention Center Department to accurately reflect the Department's staffing structure.

<u>Fiscal Impact Statement</u>: None submitted by the City Ethics Commission. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At its special meeting of December 6, 2013, the Rules, Elections and Intergovernmental Relations Committee considered a City Ethics Commission (CEC) report relative to proposed amendments to the conflict of interests code for the Los Angeles Convention Center (LACC). The CEC reports that the LACC's staffing structure will change on December 8, 2013 and its conflict of interests code has been updated to accurately refelct the new structure.
