Amendment No. 2 Agreement No. 47977 Between Los Angeles Department of Water and Power And WorleyParsons Group, Inc.

THIS AMENDMENT NO. 2 to Agreement No. 47977 (Agreement) is made and entered into by and between the City of Los Angeles, a municipal corporation acting by and through the Los Angeles Department of Water and Power, (hereinafter referred to as the "LADWP") and WorleyParsons, Group, Inc. (hereinafter referred to as "WorleyParsons").

WHEREAS, on December 20, 2010, the LADWP Board of Water and Power Commissioners (Board) approved Agreement No. 47977 for WorleyParsons to provide reclaimed water utilization services; and

WHEREAS, on February 18, 2014, the LADWP Board approved Amendment No. 1 to Agreement No. 47977 to extend the contractual period by 24 months to a revised term of 60 months, from December 20, 2010 to December 19, 2015.

WHEREAS, LADWP and WorleyParsons are desirous of amending the Agreement to extend the contract period by an additional 36 months to a revised term of 96 months, from December 20, 2010, to December 19, 2018.

NOW, **THEREFORE**, LADWP and WorleyParsons agree to amend the said Agreement as follows:

- 1. Page 4, Section 201 Term of the Agreement, is now amended to read: "The term of this Agreement shall commence, provided the events identified in Exhibit E, PSC-4 have occurred, upon execution of this Agreement by all Parties hereto and shall terminate 96 months thereafter, subject to the termination provisions herein. Performance shall not begin until the Consultant has obtained Department approval of insurance required herein."
