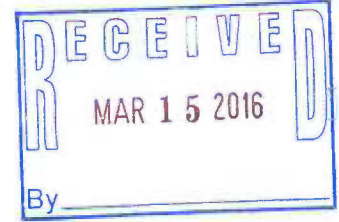

New High Mart, a California General Partnership ("NHM"), through the undersigned, hereby submits its supplement to WRITTEN PROTEST, FORM SAS 143B.

NHM hereby objects to and protests the Los Feliz Village Business Improvement District's ("LFVBID") 2016 Annual Report and the ordinance of intention, of the City Council of the City of Los Angeles to levy a special assessment for the 2016 operating year upon businesses located within the LFVBID for failing to provide the benefits to the district as outlined in the PROPERTY AND BUSINESS IMPROVEMENT DISTRICT LAW OF 1994.

The following will demonstrate how the LFVBID has not made any efforts to combat blight, promote economic opportunities, or create a clean and safe environment for customers to visit and businesses to flourish:

1. State law says a business improvement district should promote the economic revitalization and physical maintenance of business districts in order to create jobs, attract new businesses, and prevent the erosion of the business districts. Under the guidance of the current and past board:

- Multiple businesses have permanently closed.
- Long term vacancies.
- Homeless presence increased dramatically.
- Crime increase.
- Customer foot traffic decreased.

2. State law defines promotion, marketing, maintenance and security as the activities that benefit businesses in the district. Under the guidance of the current and past board:

- No promotion to bring outside shoppers and diners to district.
- No marketing to tourist industry.
- Graffiti prevalent and not removed.

- Trees trimmed only once in over 6 years allowing sidewalks to buckle
- Use of trash cans that allow homeless pilfering and wind gusts to empty.
- No sidewalk cleaning at all.
- Beautification volunteer-based despite tax-payer funding and large budget.
- Homeless excrement and vomit not removed.
- Security only provided at additional expense to tax-payer.

3. State law says that cities can only use assessment districts to pay for services that constitute special benefits for the people who pay the taxes. Services that benefit the general public, or those that function generally to raise property values, are not covered. The majority of the sitting Board are realtors and not business owners and the budget submitted and self-serving track record reflects this.

- The emphasis on “mixers” throughout the year for board to mingle with clients.
- Mixers staged at board member’s business.
- Website with no known purpose of function other than to promote board itself.
- Communications directed at district tax-payers instead of potential customers.
- Holiday shopping non-existent.
- Increased real estate values and rents have decreased customer spending.

4. The assessments levied for the purpose of conferring special benefits upon the businesses in the business district are misused.

- Over \$8,000 spent on a website built on a freeware publishing platform.
- Redundant website and directory provides no service in “Yelp” social media era.
- Printed collateral for LFVBID-to-member communications in a digital world.
- Mixers and “Village Affaire” events which do nothing to bring customers.
- A budget for \$46,000 for beautification with no discernible results.
- Wasted money on non-working holiday lights wrapped around trees. Still there.
- Lack of transparency and financial responsibility.

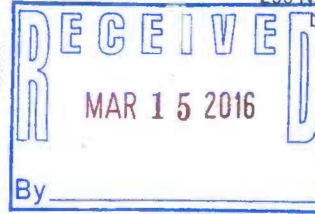
