RULES, ELECTIONS AND INTERGOVERNMENTAL RELATIONS COMMITTEE REPORT and RESOLUTION relative to establishing the City's position to support SB 1132 (Mitchell) which would impose a moratorium on fracking and acidization.

Recommendation for Council action, pursuant to Resolution (Koretz - Bonin - Wesson - Parks), SUBJECT TO THE CONCURRENCE OF THE MAYOR:

ADOPT the accompanying RESOLUTION to include in the City's 2013-14 State Legislative Program SUPPORT for SB 1132 (Mitchell), which would impose a moratorium on fracking and acidization in order to protect California's air and water from pollution caused by this dangerous form of oil and gas extraction.

Fiscal Impact Statement: None submitted by the Chief Legislative Analyst (CLA). The City Administrative Officer has not completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

At its regular meeting of May 16, 2014, the Rules, Elections and Intergovernmental Relations Committee considered a CLA report and Resolution (Koretz - Bonin - Wesson - Parks) relative to establishing the City's position to support SB 1132 (Mitchell) which would impose a moratorium on fracking and acidization. The CLA report, attached to the Council file, provides a summary of the Resolution and additional background information. After consideration and having provided an opportunity for public comment, the Committee recommended that Council adopt the accompanying Resolution.
