COMMENTS

The Department of Animal Services (ASD) requests authority to execute a contract between the City of Los Angeles (City) and the American Society for the Prevention of Cruelty to Animals (ASPCA), to provide animal spay/neuter surgeries at the South Los Angeles Animal Care Center Spay/Neuter Clinic, located at 1850 West 60th Street. The term of this contract is for three years, with an option to extend the contract for three additional years. In accordance with Los Angeles Administrative Code Section 10.5, City Council approval of the proposed agreement is required since the term could exceed three years. The proposed contract amount is not to exceed \$500,000 per year.

On October 4, 2013, the ASD issued a Request for Proposals (RFP) to solicit contract spay/neuter services for the South Los Angeles Animal Care Center. In response to the RFP, the ASPCA was selected by the Department as satisfactorily meeting the service requirements. Subsequently, on December 10, 2013, the Board of Animal Services Commissioners (Commission) reviewed and approved ASD's recommendations to contract with the ASPCA for the operation of the South Los Angeles Animal Care Center Spay/Neuter Clinic.

In accordance with Charter Section 1022, the Personnel Department completed a Contract Review Report (attached) on November 11, 2013, for the services provided at the South Los Angeles Spay/Neuter Clinic. The Personnel Department determined that although City classifications could perform the required work, the workload exceeds current staffing availability and is of limited duration, which would result in a layoff at the end of the work project.

The total cost for services under the proposed contract amendment will remain at a not-to-exceed amount of \$500,000 per year. The proposed agreement also includes the use of the facilities at the South Los Angeles Animal Care Center as governed in the facility license agreement with the General Services Department (Exhibit A of the proposed contract). The ASPCA is in compliance with the standard provisions for City contracts.

In consideration of the no-cost use of a City facility, the ASPCA will provide discounted services to the ASD equal to 50 percent of Board-approved fees for spay/neuter surgeries performed on Care Center animals and animals adopted from the Care Center. The discount shall result in a net payment equal to the discounted net fee at the 50 percent discount proposed by the ASPCA and accepted by the Board, as provided below:

In addition, the ASPCA will accept \$30 discount coupons and \$70 free sterilization certificates issued to residents by the ASD as full payment for spay/neuter surgeries. The Department will reimburse the ASPCA at the discounted value of the coupons and certificates. As part of the proposed agreement, the ASPCA will also host free vaccine events in South Los Angeles parks two to three times per year to target animals most at risk of being surrendered to the Care Center. The ASPCA will also offer free visual exams, rabies and distemper vaccinations for cats and dogs, free spay/neuter appointments, collars, leashes and flea/tick medications, in addition to general pet care informational handouts and the issuance of dog licenses. The Department anticipates the ASPCA to provide approximately 6,000 sterilizations in its first year, with an increase in its capacity to perform 8,000 surgeries during the second and third years of the agreement.

Funding for spay/neuter surgeries is provided through the Animal Sterilization Trust Fund. The Fund is established under Los Angeles Administrative Code Section 5.199 to provide funding for pet sterilization services to residents of the City of Los Angeles. A portion of funds from each paid dog license sold in the City (\$2.00 for unaltered dogs and \$7.00 for altered dogs) is deposited into the Fund to support the cost of animal sterilization. Additionally, \$710,000 has been appropriated in the General Fund 2013-14 Adopted Budget to support the Fund. Along with public donations, the Fund is expected to receive \$1.5 million in 2013-14 to support animal sterilization services.

RECOMMENDATION

That the City Council, authorize the General Manager of the Los Angeles Animal Services Department, or designee, to execute an agreement between the American Society for the Prevention of Cruelty to Animals (ASPCA) and the City of Los Angeles for spay and neuter and related services at the South Los Angeles Animal Care Center for a term of three years, from February 1, 2014 through March 31, 2017, with three one-year extension options, at an amount not-to-exceed \$500,000 per year, subject to the approval of the City Attorney as to form and legality.

FISCAL IMPACT STATEMENT

Approval of the recommendation will authorize the Los Angeles Animal Services Department to execute a contract with the American Society for the Prevention of Cruelty to Animals (ASPCA) for spay and neuter services at the South Los Angeles Animal Care Center for a maximum period of up to six years at an annual cost not-to-exceed \$500,000. Funding for this purpose is available in the Animal Sterilization Trust Fund to support animal sterilization services. There is no additional impact to the General Fund. Execution of the proposed contract agreement complies with the City's Financial Policies in that budgeted funds are used for budgeted purposes and that ongoing costs are supported by ongoing revenues.

SUMMARY: Although Animal Services employs classifications with the expertise to provide spay/neuter and other medical services to animals under their care and control, the Department asserts that their current workload does not permit them to provide adequate levels of veterinary care for adopted animals or for animals brought in by the public (which are not under their care and control). The Department states that it currently cannot hire Veterinarians within the current fiscal year to provide all the necessary services within this budget year.

SUBJECT: RECOMMENDATION TO CONTRACT WITH ASPCA TO PROVIDE SPAY AND NEUTER SERVICES

At its meeting of December 10, 2013, the Board of Animal Services Commissioners (Board) approved Department recommendations to enter into a contract with the American Society for the Prevention of Crueity to Animals (ASPCA) for the operation of a spay and neuter clinic at the South Los Angeles Animal Care Center. By a vote of 3-0, the Board approved a motion to:

- APPROVE a three-year agreement, with three one-year renewal options, substantially in the form as attached, with the American Society for the Prevention of Cruelty to Animals (ASPCA) to operate the South Los Angeles Spay/Neuter Clinic. The agreement incorporates specific changes as recommended by the Board. This approval is subject to the proposer complying with the required Office of Contract Compliance's compliance forms.
- DIRECT staff to transmit the proposed agreement concurrently to the Office of the Mayor, and the Office of the City Attorney for approval as to form, and subsequently to the City Council, and authorize the General Manager of the Department of Animal Services to execute the subject agreement upon receipt of necessary approvals;
- 3. DIRECT the Departments of Animal Services and General Services, and the City Attorney, to prepare and execute an operating agreement with a license agreement subject to the terms of the operating agreement.

BACKGROUND

The ASPCA's spay/neuter operations serve New York City's five boroughs. Their program began in 1997 and has grown into a 100-person operation with six mobile spay/neuter vans and two spay/neuter clinics. ASPCA states that it has achieved 30,000 surgeries in New York City each of the past five years. Based on ASPCA's experience, they have demonstrated a proven

track record, and possess the ability to provide spay and neuter services required by the residents in South Los Angeles.

The ASPCA proposes to provide approximately 6,000 sterilizations in its first year and increase this capacity to 8,000 surgeries in the second and third years. The ASPCA will also provide core vaccinations and a complimentary nail trim. ASPCA will offer microchips and flea medication at a subsidized rate. The organization proposes to reserve a maximum 50% of its daily caseload for shelter animals. It also would like to maintain its "holistic" approach to public outreach in Los Ángeles by hosting free vaccine events in public parks, offering free visual exams, collars, leashes, flea/tick medication and dog license applications.

The ASPCA target volume is 35 – 40 surgeries per day, five days per week. To meet this demand, the organization would hire a clinic director, veterinarian, veterinarian technician, three senior veterinarian assistants, outreach/transport coordinator, office/medical records assistant, and custodian.

The ASPCA proposes a 50% discount on the Board-approved fee schedule for spay/neuter surgeries for dogs, cats and rabbits from the shelter and those brought in by the public in connection with the City's sterilization programs. It proposes to partially or fully subsidize any fees for spay/neuter surgeries and vaccinations (offered at the time of surgery) for the public not covered by the City's \$30 discount coupon or \$70 certificate.

The Department believes ASPCA's experience, qualifications, business plan, and proposed services bring much-needed benefits to the public, and therefore recommend that ASPCA be awarded the agreement. The Department will work with General Services to develop the proper agreements needed to have a private contractor operate in a City-owned shelter.

FISCAL IMPACT:

There is no impact to the General Fund. Funds to pay shelter animal sterilizations will be used from Fund 842, Animal Sterilization Fund. The amount of the discount off Board-approved fees will free up funding to accomplish more surgeries.
