Dear Council President Wesson and Honorable Councilmembers:

I am writing in opposition to the proposed SDU repeal, scheduled to be heard at City Council tomorrow, August 23.

The offered justifications for the action include that it is necessary to comply with an LA Superior Court order, necessary to provide relief to homeowners who received permits for SDU's in reliance on the City's previous administrative process, and needed to allow for development of additional affordable housing throughout the City. None of these justifications holds up under serious scrutiny.

Stripping hillside and other protections by moving to a state default standard is a one-size-fits-all approach representing another in a long series of giveaways to speculative development in our City's residential areas. There is no indication that such a change is needed to promote affordable housing. Both evidence and logic suggest that allowing larger SDU's actually works against affordable housing: increasing the cost of production for larger units would cause sale and rental prices for those units to increase. Moreover, it is abundantly clear that residential real estate speculation is one of the major barriers to affordable housing in Los Angeles. The repeal would also be contrary to previous action by the Council in support of recognition and protection of wildlife corridors in the Santa Monica Mountains (see Council File 14-0518, adopted *unanimously* by the Council on April 22, 2016). As National Park Service Superintendent David Szymanski wrote in support of that motion: "During approximately 15 years of research in the Santa Monica Mountains, the NPS has identified increasing urbanization and habitat fragmentation as one of the key challenges to protecting local wildlife and a functioning ecosystem. The proposed [wildlife corridor] ordinance would support NPS goals and objectives to protect open space and provide for wildlife movement throughout the Santa Monica Mountains and the greater vicinity." The repeal would increase hillside area habitat and wildlife corridor fragmentation by allowing potentially millions of additional square feet of development in our City's hillside areas on a by-right basis with no environmental review whatsoever.

Moreover, the action is *not* exempt from CEQA (see my June 6, 2016 letter to the Council File, available at: http://clkrep.lacity.org/onlinedocs/2014/14-0057-s8\_pc\_06-6-16.pdf (beginning at p.2 of the linked file)).

I urge the City to reject the repeal.

Dear Councilmembers:

We are writing today on behalf of the Cheviot Hills Home Owners' Association (CHHOA) which represents 1400 households in West Los Angeles. Please let the record of proceedings on CF14-0057-S8 reflect that **CHHOA continues its unequivocal support of the existing standards** for Second Dwelling Units implemented by Los Angeles City ordinance in 2003.

Since 2013 CHHOA has remained steadfast is its opposition to the use of more lenient State standards to control the permitting and construction of Second Dwelling Units in our R-1 community, thus we <u>oppose</u> the proposed draft ordinance which far exceeds the requirements of the State Government Code as adopted pursuant to AB 1866.

### Although the CHHOA understands the need of the City to comply with the provisions of State Law adopted pursuant to Assembly Bill (AB) 1866, we strongly object to the repeal the City's currently adopted 2003 Second Dwelling Unit Standards and replacement of those standards with new less restrictive standards which echo the State "default" standards.

CHHOA understands that Government Code Section 65852.2 requires, among other matters, that municipalities with their own second dwelling unit ordinances administer them ministerially without discretionary review. However, while the State regulations become default standards for cities which <u>have not</u> adopted an ordinance governing second units, Los Angeles has an adopted ordinance! The state ordinance need not, "necessarily apply to the preparation or update of a local ordinance, they are appropriate to use as a **guideline for Cities with no SDU ordinance** in accordance with state law. (Government Code Section 65852.2(b)(1). (Emphasis added.) The proposed draft ordinance far exceeds the requirements of the State Government Code as adopted pursuant to AB 1866.

The 2003 adopted City standards evolved through a lengthy process with opportunities for Public and Decisionmakers to review. <u>They offer the fullest protection for single-family neighborhoods and families.</u> There is no urgency or need to go further than the implementation of the 2003 ordinance on a ministerial basis.

Homeowners in our communities are entitled to have a realistic opportunity to create second-units. There exists within AB 1866 allowance for cities to develop variances and zoning exceptions, and even for the development of an ancillary set of SDU regulations in addition to their locally adopted ordinance. It is

therefore unnecessary for the City to upset the 2003 ordinance with a high impact, overly broad redraft. The draft proposal for 1,200 square-foot second dwelling units (nearly double the 640 square-foot size units currently allowed) is outrageous in light of the fact that many single-family dwellings within and around CHHOA boundaries are 1200 square feet or less!

We do not oppose the City "grandfathering" the *unchallenged* permits issued under its previous, faulty administrative procedure to fairly provide relief to homeowners who reasonably relied on it, but believe the Council must not change long-standing City policy and rules protecting hillside and other areas.

For the foregoing reasons, we strongly oppose repeal of the City's Second Dwelling Unit ordinance through an emergency, fast-track action. Any changes to the ordinance must be accomplished through an open and customary deliberative process that allows for public participation.
