HOUSING COMMITTEE REPORT relative to authorization to accept and execute a \$450,000 Office of Traffic Safety Grant from the State of California.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the General Manager, Los Angeles Housing and Community Investment Department (HCIDLA), or designee, to:

- a. Accept and execute a grant agreement with the State of California Office of Traffic Safety for a grant award of \$450,000 for the Child Passenger Safety Program for the period of October 1, 2014 through September 30, 2015, subject to the approval of the City Attorney as to form and legality.
- b. Prepare Controller instructions and any necessary technical corrections consistent with Mayor and Council action on this matter, subject to the approval of the City Administrative Officer (CAO); and, authorize the Controller to implement the instructions.

2. AUTHORIZE the Controller to:

a. Increase accounts within the Office of Traffic Safety Grant Fund No. 45C and appropriate as follows:

Community Impact Statement: None submitted.


SUMMARY
