DISCUSSION

The donation will fund the DART program in collaboration with Project PeaceMakers, Incorporated. The DART unit in Southeast Area provides early intervention services that assist domestic violence victims, including children, in obtaining aid and resources. The DART officers, with their specialized knowledge, will continue to focus on the uniqueness of domestic violence investigations which result in more appropriate methods of counseling and more thorough and complete investigative reports. This program has enabled better allocation of resources by freeing up deployed units to handle non-domestic violence calls for service.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Los Angeles Police Department patents.

Administrative Services Bureau has reviewed the donation and determined that it has been submitted in accordance with Section 5.467 et seq. of the Los Angeles Administrative Code, which provides for the receipt and acceptance of donations to the Los Angeles Police Department.
