PUBLIC SAFETY COMMITTEE REPORT relative to a monetary donation to support sworn and civilian overtime for the operation of the Los Angeles Police Department (LAPD) Cadet Program.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

AUTHORIZE the LAPD to:

- a. Deposit, for sworn overtime, \$10,000.00 to Donations Trust Fund 885/70, Revenue Source 4513, and transfer the same amount to Fund 100/70, Revenue Source 1092.
- b. Deposit, for civilian overtime, \$10,000.00 to Donations Trust Fund 885/70, Revenue Source 4513, and transfer the same amount to Fund 100/70, Revenue Source 1090.
- c. Prepare Controller's instructions for any technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE the Controller to implement the instructions.

<u>Fiscal Impact Statement</u>: None submitted by the LAPD. Neither the CAO nor the Chief Legislative Officer has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY
