Both Planning and Research Division and Training Division have conducted comprehensive testing of available vehicle rifle racks and mounts. Motor Transportation Division has also been involved in the process and will be completing the installation of the devices into the vehicles. They have determined that the BLAC RAC is superior to all other rifle racks available as well as the most cost-effective rifle rack available. The Los Angeles Police Foundation, at the conclusion of the product evaluation, agreed to this one-time unsolicited donation, which is valued at approximately \$91,046.40.
