The lack of consistent and timely enforcement of project conditions in the city has been a source of great concern for many years from amongst representatives of many residential and business communities. Without consistent enforcement, our government loses credibility. Without consistent enforcement, those who follow the law appear to be at a disadvantage to those who do not (and who "get away with it"). Without consistent enforcement the entire entitlement process appears to be a charade.

An extremely valuable benefit of having a fully operational CCU is to ensure that there is a LEVEL PLAYING FIELD FOR ALL BUSINESSES IN LOS ANGELES. Those who comply with their required conditions should not feel that they are at a disadvantage for having done what is required and expected. There should be clear and consistent expectations of enforcement in the City. It is unreasonable to have different businesses being treated differently in the same jurisdiction. It would not be unreasonable to state that it is unfair to allow some businesses to skirt the law. This creates an unfair competitive position. An even-handed approach to compliance creates a better environment in which to do business. The City should seek to provide a level playing field amongst its businesses.

When conditions go unmonitored and resulting problems arise, there can be long lasting damage to the quality of life in a community including possible negative impacts on nearby property values. The early CCU work related to alcohol and entertainment-related uses was an excellent focus on particularly problematic areas.
