REPORT OF ABATE OF A PUBLIC NUISANCE

On October 30, 2009 pursuant to the authority granted by Section 91.8903 and 91.8904 of the Los Angeles Municipal Code, the Department of Building and Safety ordered the owners or other parties in interest within thirty days(30) days to secure all openings accessible for entry from the exterior of the building(s) and weatherproof the barricades installed on the parcel located at **1611 S BEDFORD ST**, within the limits of the City of Los Angeles, State of California, being more particularly described as follows:
