Dear Councilmembers:

The American Heart Association/Stroke Association writes to express our concern for the action taken on December 14th on item 14-0163-S3 removing the Vision Zero High Injury Network (HIN) from the city's proposed sidewalk repair program prioritization criteria and recommends reconsideration of inclusion of the HIN in the scoring criteria for the sidewalk repair program.

The HIN reflects areas of the city with the highest rates of people walking and biking (with an emphasis on children and older adults) and reflects the disproportionate number of traffic-related incidents concentrated in low-income and communities of color. The HIN will place higher scoring and resources in certain districts and prioritize the highest need. It will also reduce deaths and injuries of pedestrians in Los Angeles.

We urge the city to adopt the proposed city scoring system that would have given 15 points out of a possible 145 for sidewalk repairs within 500 feet of the Vision Zero High Injury Network intersections or corridors.
