Council Action

The City Council ADOPTED the following recommendation(s), contained in a COMMUNICATION FROM THE CITY ADMINISTRATIVE OFFICER which were WAIVED, pursuant to Council Rule 17, by the Chair of the Public Safety Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the City Attorney, or designee, to:
 - a. Approve the disbursement/grant award between the City and the California Attorney General's Office; and, AUTHORIZE the City Attorney, or designee, to execute the disbursement/grant award on behalf of the City, subject to the approval of the City Attorney as to form and legality.
 - b. Accept the disbursement/grant award in the amount of \$27,722.39 to support an Elder Fraud Symposium and Citywide outreach efforts following receipt of the funds for a period of 12 months thereafter.

2. AUTHORIZE the Controller to:

- a. Establish a receivable in the amount of \$27,722.39 within Fund 368/12.
- b. Establish the following appropriation account within Fund 368:

3. AUTHORIZE the City Attorney to prepare Controller instructions for necessary technical adjustments, subject to the approval of the CAO; and, AUTHORIZE the Controller to implement the instructions.
