The Bureau of Sanitation and the Planning Department are seeking to apply for State Proposition 84 grants of \$500,000 each as follows:

Bureau of Sanitation - application for the Greenways to Rivers Arterial Stormwater System (G.R.A.S.S.) Regional Stormwater Greenprint in order to develop a regionally scaled arterial stormwater greenway network composed of an interconnected series of vegetated systems and proven technologies to manage storm water runoff and beautify the public rights-of-way in disadvantaged and park poor neighborhoods within the City of Los Angeles - \$500,000;

Planning Department - application to develop the Sustainable and Equitable Planning for Infill in Transit Priority Areas Program, which includes developing local trip generation characteristics of affordable housing and mixed use development; developing a standard list of mitigation measures to reduce project-related VMT impacts; and taking steps to revise the transportation-related CEQA Thresholds - \$500,000.

Action is needed to authorize these departments to apply for the grants and to approve the attached Resolutions as required by the granting agency.

I THEREFORE MOVE that the Bureau of Sanitation and the Planning Department be authorized to apply for State Proposition 84 grants of \$500,000 each as further described in the text of this Motion.

I FURTHER MOVE that the Council adopt the attached Resolutions as required by the granting agency.

I FURTHER MOVE that the involved City departments be directed to report with recommendations and to seek further Council approval upon award of either of these grants and prior to execution of any related agreements which commit City resources.
