An ordinance reinstating with amendments Subdivision 7 of Subsection B of Section 63.44 of Article 3 of Chapter VI of the Los Angeles Municipal Code, and amending Subdivision 11 of Subsection B of Section 63.44 of Article 3 of Chapter VI of the Los Angeles Municipal Code to protect wildlife.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Sec. 1. Subdivision 7 of Subsection B of Section 63.44 of the Los Angeles Municipal Code is reinstated with amendments to read as follows:

7. No person shall use any area or facility set aside, used, maintained or designated for a specific recreational or park purpose by the Board, Department or Commission, where reasonable notice of such designation or purpose is given by signs posted thereon, for a purpose contrary to or inconsistent with such specific or designated purpose.

Sec. 2. Subdivision 11 of Subsection B of Section 63.44 of the Los Angeles Municipal Code is amended to read as follows:

11. No person shall take, seize, disturb or hunt any bird, animal, nest, egg or fish, except that a person may search for a lost or escaped dog, cat or horse.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
