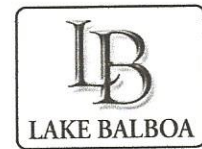

Re: CF 14-0356 Proposed revision of Municipal Code Section 63.44(M)

Councilmembers,

On April 2, 2014, the Lake Balboa Neighborhood Council Board met at a regularly scheduled and agendized meeting and passed the following motion by a vote of 15-0.

- Whereas, There is documentation of a recent increase in the numbers of people treating the Sepulveda Basin Wildlife Areas as a hunting and fishing ground,
- Whereas, There are no current enforceable city ordinances prohibiting this behavior in city wildlife areas, and
- Whereas, Existing Municipal Code Section 63.44 contains regulations prohibiting behaviors in city park and recreation areas including the taking of all animals, removal of plants and soil; and fires, littering and firearms,
- Therefore, Lake Balboa Neighborhood Council endorses CF 14-0356 and supports the City Council request for the City Attorney prepare an ordinance to extend the current prohibitions of MO Section 63.44 to the City's Wildlife Areas, including but not limited to the following: taking of animals; removal of plants and soil; and the taking of birds and eggs.
