Comments for Public Posting: Dear Honorable Council Members of the City of Los Angeles: My name is David Ramyar Khoshbin, I am a Phase 2 social equity program applicant and my business is within Council District 9 (Curren Price). Given the current relocation restrictions, I have experienced predatory practices from my landlord and have not been able to schedule my pre-inspection or relocate to another location and complete my build-out. I have been communicating with the DCR for the last year to ask for help and to implement a “Social Equity Emergency Rule”, which would allow social equity program participants to request changes of address based on unforeseen circumstances, including predatory practices from investors, landlords and other partners. I hoped that this process would take a month or two, but now a year later many Phase II applicants are still in limbo, because changing the ordinance to allow cannabis businesses to move requires action by the Council and the Rules, Elections and Intergovernmental Relations Committee. I am here to strongly support and encourage the City Council to adopt DCR's policy recommendation to allow for the relocation of Business Premises and ask that the City Council also grant Phase 2 Social Equity Applicants more time to conduct their “initial Inspection”, before July 3rd, 2020, or Phase 2 Social Equity Applicants may be at risk of the DCR deeming our applications abandoned. Also based on unforeseen circumstances and emergencies, such as Covid-19, the DCR should have the authority to consider other application modifications on a case-by-case basis. Thank you again for your time and attention, we appreciate the City's efforts to rectify the Social Equity Program and its true intentions.
