RE: Confirmation of Ms. Cat Packer as the Director of the Los Angeles Department of Cannabis Regulation

Dear Honorable Members of the Los Angeles City Council:

The confirmation of Ms. Cat Packer as the Director of the Los Angeles Department of Cannabis Regulation will shortly come before you. Americans for Safe Access urges you to confirm Ms. Packer and fully supports her appointment for the following reasons:

Ms Packer, in her position at the Drug Policy Alliance, has demonstrated a thoughtful, thorough and rational approach to policy. She is neither a zealot nor a martinet, but rather someone who thinks deeply about issues and supports her conclusions with facts, not emotion. Thus, the very foundations of the department she will head will be based on carefully reasoned decisions that will ensure that the department is run efficiently. Our organization is confident that her stewardship will be in the best interests of the City, as well as those who will depend on the department for guidance and licensure.

The trajectory of Ms. Packer's education, which includes a law degree, have given her a skill set that will allow her to work through the difficult and complex work of setting up a new City Department, one that will require both the ability to work through difficult technical issues, like the establishment of IT programs and the staffing of a brand new agency.

Additionally, she is politically astute. Ms. Packer was not only a great advocate for the legalization of cannabis, but has also played a meaningful role in getting state legislation passed, often legislation that had nothing to do with cannabis, but addressed other, urgent matters. Thus, her appointment ensures that the head of a department that will deal with conflicting local, state and federal issues has a demonstrated history of success in dealing with myriad, complex legislation successfully.

For the reasons stated above, we urge the Council to confirm Ms. Packer's appointment when it comes before the honorable body. We endorse Ms. Packer's appointment without reservation and are confident that her appointment is in the best interests of the City of Los Angeles.
