

I MOVE that the City Council actions taken on April 8, 2014 (CF 14-0396) and June 10, 2014 (CF 13-1395-S3) BE AMENDED to rename line item River Corps (formerly River Keepers) (CD1) to "CD 1 LACC River Corps/CD1 Community Clean Up Program" to continue community beautification efforts in CD1.

I FURTHER MOVE that the Board of Public Works, Office of Community Beautification, be authorized to:

1. Negotiate and execute contracts with the following organizations up to and not exceeding the below amounts, subject to the approval of the City Attorney as to form, for the purpose of carrying out community beautification projects in CD 1.

Los Angeles Conservation Corps:	\$100,000
Central City Action Committee:	\$50,000
Northeast Graffiti Busters:	\$50,000
<u>Koreatown Youth &amp; Community Center</u>	<u>\$25,000</u>
Total	\$225,000

2. Make any technical changes and prepare any necessary Controller instructions that may be required to effectuate the intent of this motion, subject to the approval of the Chief Legislative Analyst, and authorize the Controller to implement said instructions.
