Dear Councilman Huizar:

We're writing today to urge you to pass the motion referenced above, which would explore the viability of using L050 tax monies for the enforcement of Proposition D. To demonstrate how urgent the problem is, we have prevailed upon the Finance Department to supply a list of L050 Business Tax Registration Certificates by Council District. Those relating to your district are attached.

On the right hand side you will see your Council District highlighted in yellow, which indicates that particular L050 would locate itself in your District. As of May 12, 2014, **eighty-eight entities have pulled L050's to locate in your district.**

Collectively, among the three members of your committee, 137 L050 BTRC's have been pulled. Without a dedicated stream of income for the Los Angeles City Attorney, you may never see all of the illegal operations shuttered.

The City Attorney has hit upon a winning formula and has had over one hundred successful cases so far. His department has already demonstrated that their methods achieve the results the City needs. Dedicating L050 tax monies to enforcement will ensure that the City Attorney has adequate funds and will speed enforcement efforts.
