COMMITTEE TRANSMITTAL: AUTHORIZATION TO ACCEPT \$3,022,000 IN LOS ANGELES COUNTY DEPARTMENT OF PUBLIC SOCIAL SERVICES TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) FUNDS FOR IMPLEMENTATION OF A YOUTH WORK EXPERIENCE PROGRAM

## RECOMMENDATIONS

The General Manager of the Economic and Workforce Development Department (EWDD) and the Chairman of the Workforce Investment Board (WIB) respectfully request that the Mayor and City Council:

- 1. AUTHORIZE the General Manager of EWDD, or designee, to accept funds from and to execute grant agreements and/or unilateral amendments with the County of Los Angeles for receipt of Temporary Assistance for Needy Families (TANF) funds for implementation of a youth work experience program.
- 2. AUTHORIZE the General Manager of EWDD, or designee, to contract with the providers listed on Attachment A to provide youth services from April 1, 2014 through June 30, 2014.
- 3. AUTHORIZE the Controller to:

- a. Establish a new interest-generating fund titled Temporary Assistance for Needy Families (TANF) Fund No. XXX. This fund will be used to track the grant funds received from LA County and will be administered by EWDD.
- b. Establish a receivable within the newly-established Temporary Assistance for Needy Families (TANF) Fund No. XXX for \$3,022,000.
- c. Establish a new account and appropriate within the newly-established Temporary Assistance for Needy Families (TANF) Fund No. XXX as follows:

- f. Expend up to \$240,000 within the newly-established Temporary Assistance for Needy Families (TANF) fund for participant stipends and incentives upon presentation of proper documentation.
- 4. AUTHORIZE the General Manager of EWDD, or designee, to prepare such Controller's instructions as are necessary to implement actions approved by the Council and Mayor, on matters presented in or deriving from this transmittal, and/or to make necessary technical adjustments, subject to review by the City Administrative Officer; and further request that the Controller implement such instructions.

## WIB ACTION

It is anticipated that the City of Los Angeles Workforce Investment Board (WIB) will approve acceptance and expenditure of these grant funds at the WIB Executive meeting on April 10, 2014.

## **FISCAL IMPACT**

There is no negative impact on the General Fund as all items are funded through this grant award. Recommendations contained herein provide full cost recovery for all related costs.

### BACKGROUND

In March 2014, the County of Los Angeles Department of Community and Social Services (DCSS) advised EWDD of its award of \$3,022,000 in TANF funds for provision of youth work employment services. Program participation is targeted to youth 14-21 years old who receive TANF funds. The term of the award is April 1, 2014 through June 30, 2014 with youth development and work experience activities occurring primarily during May 2014 and June 2014.

The program goals are to provide 1,553 youth with the opportunity to gain work experience, to participate in personal development workshops on topics that include work readiness and financial literacy, and to earn wages. Participants will be placed in work experience with non-profit, governmental, and private sector worksites and will work toward completion of 120 hours. Supportive services such as transportation assistance will also be provided.

The program will be implemented through the EWDD's YouthSource system contractors and through organizations procured through the 2013 Youth and Young Adult System Support Request for Qualifications (RFQ).

A request to participate was sent to the 19 eligible YouthSource System summer youth contractors on March 18, 2014. Of the 19 eligible YouthSource system summer youth providers, 15 contractors responded and 1 withdrew, resulting in 14 contractors requesting a total of 4,450 youth jobs for the available 1,553 jobs. A program allocation was developed (see attachment A). The 1,553 TANF youth jobs were allocated by the percentage of youth in poverty as determined by the American Community Survey (ACS) and geographic planning areas.
