**RESOLUTION OF THE GOVERNING BOARD OF THE MOUNTAINS RECREATION
AND CONSERVATION AUTHORITY SUPPORTING SANTA MONICA
MOUNTAINS (HILLSIDE ORDINANCE ZONE) WILDLIFE CORRIDOR
ORDINANCE (CF 14-0518 KORETZ), CITY OF LOS ANGELES**

Resolved, That the Governing Board of the Mountains Recreation and Conservation Authority (MRCA) hereby:

1. FINDS that the City of Los Angeles' proposed Santa Monica Mountains Wildlife Corridor Ordinance is fundamental to maintaining adequate longterm habitat connectivity in the City's portion of the mountain range; and
2. FINDS that the proposed action is categorically exempt from the provisions of the California Environmental Quality Act (CEQA); and
3. ADOPTS the staff report and recommendation dated July 2, 2014; and
4. AUTHORIZES all means of support to ensure the City of Los Angeles' adoption of a Santa Monica Mountains Wildlife Corridor Ordinance in the Hillside Zone area; and
5. AUTHORIZES the Executive Officer to do any and all acts necessary to carry out this resolution and any recommendations made by the Governing Board.
