Your work to establish the Hillsides Zones and related protective ordinances in Northeast Los Angeles was a powerful step in managing the impacts of development in our area's unique natural spaces.

We as a community continue to explore and refine our understanding of the intersection between the built and natural worlds and navigate toward healthy coexistence.
