Ms. Dickinson,

Save Coldwater Canyon (SCC) supports the Wildlife Corridor / Santa Monica Mountains (Hillside Ordinance Zone). We welcome this motion to protect LA's wildlife and wildlife corridor. Hillside development projects should be reviewed and screened for wildlife habitat connectivity to ensure permeability.

SCC is a neighborhood group striving to preserve and protect the natural environment and scenic beauty of Coldwater Canyon and its neighboring communities. We are very concerned that building density in the hillsides and the urbanization of the few remaining open spaces we have left in the hillsides are changing entire species and endangering their viability. As wildlife corridors are blocked, reduced and fragmented, the health and survival of roaming, breeding, and nesting wildlife is threatened.

We support requiring City Planning and PLUM to consider wildlife corridors in any new hillside developments, and to seek scientific guidance to keep wildlife habitat linkages and corridors open.

- We support requiring a Biological Constraints Checklist and Wildlife Permeability Review as part of every new building project application in the hillsides of LA.
- We support No issuance of building or grading permits until project applicants ensure that they will permanently accommodate wildlife habitat connectivity as part of their development projects.
- We support requiring easements or deed restrictions in perpetuity to protect wildlife habitat connectivity.
- We support formally designating a Regional Wildlife Habitat Linkage Zone in the Municipal Code, in as much as just one single-family residential project can cause adverse impacts and threatened wildlife populations.

Thank you to Councilmember Koretz, and the other Councilmembers who signed on to this motion. We support it and hope PLUM does too.
